7 AN ORDINANCE CONFIRMING THE APPOINTMENT OF
8 NICOLE HAMM, AS A MEMBER OF THE PUBLIC SERVICE
9 GRANT COUNCIL, WITH GRANT EXPERIENCE, REPLACING
10 DOGAN TOZOGLU, PURSUANT TO SECTION 80.102
11 (COMPOSITION; MEMBER QUALIFICATIONS; TERMS;
12 ANNUAL TRAINING REQUIREMENT; RESPONSIBILITIES),
13 CHAPTER 80 (PUBLIC SERVICE GRANT COUNCIL),
14 *ORDINANCE CODE*, FOR A FIRST FULL TERM TO EXPIRE
15 ON DECEMBER 31, 2026; REQUESTING ONE CYCLE
16 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

18 **WHEREAS**, the initial grant process for the Public Service Grant
19 ("PSG") Council requires the attention and input of PSG members and
20 will begin imminently; and

21 **WHEREAS**, PSG Council members are needed to complete member
22 training, fill vacancies, appoint PSG officers and begin providing
23 their expertise to the PSG Council as expeditiously as possible; now
24 therefore

25 **BE IT RESOLVED** by the Council of the City of Jacksonville:

26 **Section 1. Appointment.** The Council hereby confirms the
27 Mayor's appointment of Nicole Hamm, a Duval County resident, to the
28 Public Service Grant Council, with grant experience, replacing Dogan
29 Tozoglu, pursuant to Section 80.102 (Composition; Member
30 Qualifications; Terms; Annual Training Requirement;

1 Responsibilities), Chapter 80 (Public Service Grant Council),
2 *Ordinance Code*, for a first full term to expire on December 31, 2026.

3 **Section 2. Requesting One Cycle Emergency Passage Pursuant**
4 **to Council Rule 4.901 (Requesting Emergency Passage).** One cycle
5 emergency passage of this Ordinance is requested to enable the
6 appointee to participate in member training and to participate
7 meaningfully in the time-sensitive initial grant process which begins
8 imminently.

9 **Section 3. Effective Date.** This Ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
