5 AN ORDINANCE AMENDING PART 16 (TRUCK ROUTE
6 REGULATIONS), CHAPTER 804 (JACKSONVILLE TRAFFIC
7 CODE), ORDINANCE CODE, TO AMEND SECTION 804.1607
8 (CERTAIN DUMP TRUCKS PROHIBITED) TO PROHIBIT
9 OPERATORS OF DUMP TRUCKS WITH 10 OR MORE WHEELS
10 FROM DRIVING ON, TRAVELING OVER OR USING THAT
11 PORTION OF ROADWAYS FROM THE NORTHERNMOST POINT
12 OF SAWPIT ROAD TO CEDAR POINT ROAD, WEST ON CEDAR
13 POINT ROAD TO GROVER ROAD, AND REMOVING THE
14 PROHIBITION ON THE REMAINING PORTION OF CEDAR
15 POINT ROAD WEST AND SOUTH ON NEW BERLIN ROAD
16 UNTIL ITS TERMINATION AT HECKSCHER DRIVE IN
17 JACKSONVILLE, AND ADDING AN EXEMPTION FOR
18 PROPERTY OWNERS USING THOSE ROADWAYS AS THEIR
19 SOLE MEANS OF INGRESS AND EGRESS TO PROPERTY;
20 PROVIDING FOR AN EFFECTIVE DATE.

22 **Section 1. Amending Part 16 (Truck Route Regulations),**
23 **Section 804.1607 (Certain Dump Trucks Prohibited), Chapter 804**
24 **(Jacksonville Traffic Code), Ordinance Code.** Part 16 (Truck Route
25 Regulations), Chapter 804 (Jacksonville Traffic Code), *Ordinance*
26 *Code*, is hereby amended to read as follows:

27 **CHAPTER 804. JACKSONVILLE TRAFFIC CODE.**

29 **PART 16. TRUCK ROUTE REGULATIONS**

31 **Sec. 804.1607 - Certain Dump Trucks Prohibited.**

1 (a) Operators of Dump Trucks having ten or more wheels are
2 hereby prohibited from traveling over, driving on or using
3 that portion of roadways from the northernmost point of
4 Sawpit Road, south to Cedar Point Road, west on Cedar Point
5 Road to ~~New Berlin Road~~ Grover Road in Jacksonville. This
6 prohibition shall not apply to any Dump Truck that is
7 legally stored on and operated from any property that is
8 owned or leased by the vehicle owner in an area where any
9 roadway identified in this section provides the sole means
10 of ingress or egress.

11 (b) The Jacksonville Sheriff's Office shall enforce this
12 Section in accordance with the provisions of Section
13 804.1606, Ordinance Code, provided a warning shall be
14 issued for six months after enactment of this Section.

16 **Section 2. Effective Date.** This Ordinance shall become
17 effective upon signature by the Mayor or upon becoming effective
18 without the Mayor's signature.
