ORDINANCE 2023-608-E

AN ORDINANCE APPROPRIATING \$300,000.00 FROM GENERAL FUND/GSD OPERATING RESERVES TO SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS FOR A GRANT TO CLARA WHITE MISSION, INC., FOR THE WHITE HARVEST FARMS CULINARY VOCATIONAL TRAINING PROGRAM; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY, A CITY GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND CLARA WHITE MISSION, INC.; INVOKING THE EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW A DIRECT CONTRACT WITH CLARA WHITE MISSION, INC.; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2023-2024 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s)

(c) Explanation of Appropriation - The appropriation above is a transfer of funding from General Fund/GSD Operating Reserves to provide funding to Clara White Mission, Inc., in support of its White Harvest Farms culinary vocational training program.

Section 2. Purpose. The purpose of the appropriation in Section 1 above is to provide funding from the City of Jacksonville to Clara White Mission, Inc., for its White Harvest Farms culinary vocational training program. This program will provide education and training in culinary arts, food production and service, and agriculture, targeting low-income residents in north Jacksonville, individuals residing in food deserts, and homeless veterans. Individuals served through this program will also receive supportive services including case management, job readiness preparation, and job placement.

Section 3. Approval and Authorization to Execute. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to negotiate and execute a grant agreement, including amendments thereto, in accordance with Chapter 118, Parts 1-5, Ordinance Code, with Clara White Mission, Inc., in a not-to-exceed amount of \$300,000.00 for the 2023-2024 fiscal year to be used for operation of the White Harvest Farms program, subject to the terms, scope and conditions more fully described in Exhibit 2, attached hereto and incorporated herein by this reference.

Code. The City is hereby authorized to enter into a grant agreement with Clara White Mission, Inc., to provide funding for operation of the White Harvest Farms program. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 5. Waiver of Section 118.107, Ordinance Code. The provisions of Section 118.107 (Nonprofits to receive funding through a competitive evaluated award process), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow for a direct contract with Clara White Mission, Inc. The City finds that this is a justified direct contract because Clara White Mission, Inc.'s, White Harvest Farms culinary vocational training program will provide culinary and agricultural training to members of the community with a goal to increase food sovereignty and security among Jacksonville's most vulnerable populations.

Section 6. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that this funding was recommended by Council Members Howland, White, Arias, Carrico, and Gaffney, Jr., during the August 25, 2023, budget meeting of the Finance Committee. This funding was not included in the amendments to Ordinance 2023-504 due to a conflict of interest that would arise for a Council Member. Emergency action is requested so that this legislation can be taken up in conjunction with Ordinance 2023-504 and approved as part of the City's budget package.

Section 7. Oversight Department. The Grants and Contract 1 2 Compliance Division within the Department of Finance 3 Administration shall oversee the project described herein. 4 5 6 7 Form Approved: 8 9

Section 8. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
