ORDINANCE 2024-43-E

AN ORDINANCE APPROPRIATING \$75,000 FROM DESIGNATED CONTINGENCY ACCOUNT WITHIN GENERAL FUND TO THE SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT WITHIN THE KIDS HOPE ALLIANCE ("KHA") FUND TO PROVIDE FUNDING TO ELEVATE JACKSONVILLE INC. ("ELEVATE JAX") FOR THE ELEVATE JACKSONVILLE AT WESTSIDE HIGH SCHOOL "PROGRAM") DESCRIBED HEREIN; PROGRAM (THE AMENDING THE THIRD REVISED SCHEDULE M ORDINANCE 2023-511-E; INVOKING THE EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH ELEVATE JAX; WAIVING THE REQUIREMENTS OF SECTION 77.111(A) (PROVIDER CONTRACTS), CHAPTER (KIDS HOPE ALLIANCE), ORDINANCE CODE, EXEMPT THE SERVICES TO BE PROVIDED BY ELEVATE JACKSONVILLE INC. FROM COMPETITIVE PROCUREMENT; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF KHA TO EXECUTE AND DELIVER AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE OR KHA AND ELEVATE JACKSONVILLE INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2023-2024 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above is an appropriation of \$75,000 from a Designated Contingency account within the General Fund to the Subsidies and Contributions to Private Organizations account within the Kids Hope Alliance ("KHA") Fund to provide funding to Elevate Jacksonville Inc. ("Elevate Jax") for the Elevate Jacksonville at Westside High School Program (the "Program") to pay the salary and benefits for a teacher-mentor and the partial expenses for a site coordinator at Westside High School for the 2023-2024 academic year.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding from the City of Jacksonville to Elevate Jax for the Program as described in Exhibit 2, attached hereto and incorporated herein by this reference. The Program will entail placing a teacher-mentor and a site coordinator at Westside High School for the 2023-2024 academic year. The teacher-mentor will spend 50% of his/her time teaching accredited elective classes at Westside High School. These classes incorporate character qualities and life

skills into the daily classroom curriculum through experiential learning, group activities, and discussions. These qualities and skills are designed to develop the personal character, leadership abilities, and capabilities needed for success.

Section 3. Amending Third Revised Schedule M to Ordinance 2023-511-E. The Kids Hope Alliance fiscal year 2023-2024 budget approved by Ordinance 2023-511-E is hereby amended by substituting in the place of the Third Revised Schedule M, the Fourth Revised Schedule M, attached hereto as Exhibit 3 and incorporated herein by this reference. The Fourth Revised Schedule M reflects the funds appropriated herein as well as adjustments approved by the Council pursuant to Ordinance 2023-847-E.

Section 4. Invoking the Exemption in Section 126.107(g), Ordinance Code. The City is hereby authorized to directly procure the professional services of Elevate Jacksonville Inc. to administer the Program described herein. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 5. Waiving the Requirements of Section 77.111(a), Ordinance Code. The City hereby waives the requirements of Section 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance), Ordinance Code, with respect to the contract with Elevate Jacksonville Inc. approved and authorized by this Ordinance. Section 77.111(a) requires contracts for children's services provided by third parties to be competitively procured by KHA via an evaluated bid process. This waiver is needed in order to allow KHA to directly contract with
