5 A RESOLUTION SUPPORTING HOUSE BILL 0385
6 DESIGNATING A PORTION OF U.S. ROUTE 90 BETWEEN
7 YELLOW WATER ROAD AND LOG ROAD IN DUVAL COUNTY
8 AS "TROOPER ROBERT P. MCDERMON MEMORIAL
9 HIGHWAY"; DIRECTING THE CHIEF OF LEGISLATIVE
10 SERVICES TO SEND A COPY OF THIS RESOLUTION TO
11 THE FLORIDA DEPARTMENT OF TRANSPORTATION,
12 DUVAL LEGISLATIVE DELEGATION, THE FLORIDA
13 SENATE PRESIDENT AND THE SPEAKER OF THE
14 FLORIDA HOUSE; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, during the 2019 Legislative Session, the Florida
17 Legislature passed House Bill 0385, which makes honorary
18 designations of transportation facilities throughout Florida and
19 directs the Florida Department of Transportation (FDOT) to erect
20 suitable markers for those designations; and

21 **WHEREAS**, House Bill 0385 designates that portion of U.S. Route
22 90 (72010000) between Yellow Water Road and Log Road in Duval
23 County as "Trooper Robert P. McDermon Memorial Highway"; and

24 **WHEREAS**, Section 334.071, Florida Statutes, provides that a
25 city or county must pass a resolution in support of a particular
26 designation before road markers are erected; and

27 **WHEREAS**, the City of Jacksonville wishes to honor Trooper
28 Robert P. McDermon and requests that the Florida Department of
29 Transportation erect suitable markers designating a portion of U.S.
30 Route 90 (72010000) between Yellow Water Road and Log Road in Duval
31 County as "Trooper Robert P. McDermon Memorial Highway"; now

1 therefore

2 **BE IT RESOLVED** by the Council of the City of Jacksonville:

3 **Section 1.** The City of Jacksonville strongly supports
4 House Bill 0385, and designation of a portion of U.S. Route 90
5 (72010000) between Yellow Water Road and Log Road in Duval County
6 as the "Trooper Robert P. McDermon Memorial Highway," and hereby
7 authorizes the erection of appropriate signage by the Florida
8 Department of Transportation to commemorate the designation.

9 **Section 2. Direction to Chief of Legislative Services.**
10 The Chief of Legislative Services for the City Council is hereby
11 directed to provide a copy of this Resolution to the Florida
12 Department of Transportation, Duval County Legislative Delegation,
13 Florida Senate President and Speaker of the Florida House.

14 **Section 3. Effective Date.** This Resolution shall become
15 effective upon signature by the Mayor or upon becoming effective
16 without the Mayor's signature.
