4 **ORDINANCE 2019-762-E**

5 AN ORDINANCE APPOINTING LANE BURNETT AS A
6 MEMBER OF THE JACKSONVILLE WATERWAYS
7 COMMISSION, PURSUANT TO CHAPTER 95, *ORDINANCE*
8 *CODE*, REPLACING JED V. DAVIS AS A GENERAL
9 PUBLIC REPRESENTATIVE, FOR A PARTIAL TERM TO
10 EXPIRE DECEMBER 31, 2019, FOLLOWED BY A FIRST
11 FULL TERM TO EXPIRE DECEMBER 31, 2022; WAIVING
12 SECTION 95.103(C) (MEMBERSHIP; TERMS;
13 COMPOSITION), *ORDINANCE CODE*, AS TO THE
14 PROVISION THAT NO MEMBER MAY BE ELIGIBLE FOR
15 APPOINTMENT FOR THE NEXT SUCCEEDING TERM;
16 PROVIDING AN EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Appointment.** The Council hereby appoints Lane
20 Burnett, a Duval County resident, to the Jacksonville Waterways
21 Commission, replacing Jed V. Davis as a general public
22 representative, in accordance with Chapter 95, *Ordinance Code*, for
23 a partial term to expire December 31, 2019, followed by a first
24 full term to expire December 31, 2022.

25 **Section 2. Waiving Section 95.103(c) (Membership; Terms;**
26 **Composition), Ordinance Code.** The Provision of Section 95.103(c)
27 (Membership; Terms; Composition), Chapter 95 (Jacksonville
28 Waterways Commission), *Ordinance Code*, states in pertinent part
29 "After serving three consecutive full terms, no member may be
30 eligible for appointment for the next succeeding term." Lane
31 Burnett has served on the Jacksonville Waterways Commission for

1 three consecutive terms, with the last term expiring March 10,
2 2017. The term for which this appointment is being made is during
3 what would be Lane Burnett's "following consecutive term." The
4 Council hereby waives the provision of Section 95.103(c), *Ordinance*
5 *Code*, to allow Lane Burnett to serve for 5 months of what would be
6 the "following consecutive term."

7 **Section 3. Effective Date.** This Ordinance shall become
8 effective upon signature of the Mayor or upon becoming effective
9 without the Mayor's signature.
