4 **ORDINANCE 2024-939**

5 AN ORDINANCE APPROPRIATING \$202,381 FROM A  
6 GENERAL FUND OPERATING SPECIAL COUNCIL  
7 CONTINGENCY ACCOUNT TO THE AUTHORIZED CAPITAL  
8 PROJECTS - FY23 AND FORWARD FUND - VETERANS  
9 MEMORIAL WALL SHADE STRUCTURE PROJECT -  
10 ENGINEERING AND DESIGN ACCOUNT TO PROVIDE  
11 INITIAL FUNDING FOR THE PROJECT; AMENDING THE  
12 2025-2029 FIVE-YEAR CAPITAL IMPROVEMENT PLAN  
13 APPROVED BY ORDINANCE 2024-505-E TO REFLECT THIS  
14 APPROPRIATION OF FUNDS TO THE PROJECT; PROVIDING  
15 FOR OVERSIGHT BY THE DEPARTMENT OF PUBLIC WORKS  
16 AND THE MILITARY AND VETERANS AFFAIRS  
17 DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2024-2025 fiscal year,  
21 within the City's budget, there is hereby appropriated the indicated  
22 sum(s) from the account(s) listed in subsection (a) to the account(s)  
23 listed in subsection (b):

30 (c) Explanation of Appropriation:

31 The funding above represents an appropriation of \$202,381

1 from a General Fund Operating Special Council Contingency  
2 account to the Authorized Capital Projects - FY23 and  
3 Forward Fund - Veterans Memorial Wall Shade Structure  
4 project - Engineering and Design account to provide initial  
5 funding for a permanent shade structure at the Veterans  
6 Memorial Wall.

7 **Section 2. Purpose.** The purpose of the appropriation in  
8 Section 1 is to provide initial funding for a permanent shade  
9 structure to be constructed at the Veterans Memorial Wall located at  
10 1145 East Adams Street in downtown Jacksonville. It is anticipated  
11 that additional funding for the project will be obtained through  
12 private donations or additional appropriations in the future.

13 **Section 3. Capital Improvement Plan Amendment.** Ordinance  
14 2024-505-E, adopting the 2025-2029 Five-Year Capital Improvement Plan  
15 (the "CIP") for the City and certain of its independent agencies, is  
16 hereby amended to add a new project entitled "Veterans Memorial Wall  
17 Shade Structure" (the "Project") and to reflect initial funding for  
18 the Project, as more fully described in the Project Information Sheet  
19 attached hereto as **Exhibit 2** and incorporated herein by this  
20 reference. The City Council finds that the deferral of this amendment  
21 of the CIP until the next annual budget and CIP review will be  
22 detrimental to the best interests of the community because such  
23 deferral will unnecessarily delay commencement of the Project and  
24 design of the proposed shade structure at the Veterans Memorial Wall.

25 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of  
26 this Ordinance requires the affirmative vote of two-thirds of the  
27 City Council members present at the meeting because of the CIP  
28 amendment set forth in this Section. This Ordinance shall constitute  
29 an amendment to Ordinance 2024-505-E. In all other respects, the  
30 Five-Year Capital Improvement Plan approved by Ordinance 2024-505-E  
31 shall remain unchanged and continue in full force and effect.

1           **Section 4.       Oversight.** The Department of Public Works and  
2 the Military Affairs and Veterans Department shall oversee the project  
3 described herein.

4           **Section 5.       Effective Date.** This Ordinance shall become  
5 effective upon signature by the Mayor or upon becoming effective  
6 without the Mayor's signature.
