4 **ORDINANCE 2024-741-E**

5 AN ORDINANCE APPROPRIATING \$3,044,035.43 FROM  
6 THE INMATE WELFARE TRUST FUND TO ESTABLISH THE  
7 FISCAL YEAR 2024-2025 OPERATING BUDGET FOR THE  
8 INMATE WELFARE TRUST FUND, AS INITIATED BY B.T.  
9 25-007; AUTHORIZING A POSITION WITHIN THE INMATE  
10 WELFARE TRUST FUND, AS INITIATED BY R.C. 25-006;  
11 PROVIDING AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Appropriation.** For the 2024-2025 fiscal year,  
15 within the City's budget, there is hereby appropriated the indicated  
16 sum(s) from the account(s) listed in subsection (a) to the account(s)  
17 listed in subsection (b):

24 (c) Explanation of Appropriation:

25 The funding above is from the Inmate Welfare Trust Fund  
26 (the "Trust Fund") to establish the Trust Fund's fiscal  
27 year 2024-2025 operating budget in accordance with Section  
28 111.300, *Ordinance Code*, and Section 951.23(9), *Florida*  
29 *Statutes*. The sources of the funds are projected fiscal  
30 year 2024-2025 revenues.

31 **Section 2. Purpose.** The purpose of the appropriation in

1 Section 1 is to establish the fiscal year 2024-2025 operating budget  
2 for the Trust Fund in accordance with Section 111.300, *Ordinance*  
3 *Code*, and Section 951.23(9), *Florida Statutes*. The appropriation  
4 includes \$181,348.45 in various salary accounts for employees whose  
5 duties directly relate to the Trust Fund; \$362.62 in City employees'  
6 Worker's Compensation; \$3,201.00 for general liability insurance;  
7 \$941,336.36 for admission packs, indigent packs, law library  
8 supplies, recreational equipment, replacement servers for existing  
9 security cameras, and other related items; \$475,552.00 for Computer  
10 Equipment for various capital equipment items at the Pre-Trial  
11 Detention Facility; and \$1,442,235.00 for Specialized Equipment for  
12 various capital equipment items at the Montgomery Correctional  
13 Facility and Pre-Trial Detention Facility. There are no requirements  
14 for a local match or additional staffing obligations associated with  
15 this appropriation.

16 **Section 3. Authorization of Position.** There is hereby  
17 authorized the position more fully described in R.C. 25-006, attached  
18 hereto as **Exhibit 2** and incorporated herein by this reference.

19 **Section 4. Effective Date.** This Ordinance shall become  
20 effective upon signature by the Mayor or upon becoming effective  
21 without the Mayor's signature.
