20 **BE IT ORDAINED** by the Council of the City of Jacksonville: 21 Section 1. Closure and Abandonment. An unopened and 22 unimproved portion of two unnamed Rights-of-Way as recorded in Plat 23 Book 3, Page 41, Plat of Jacksonville Farms, of the current public records of Duval County, Florida, located in Council District 12, a 24 25 depiction and description of which is attached hereto as Revised 26 Exhibit 1, labeled as "Revised Exhibit 1, Rev Map & Sketch, June 17, 27 2025 - TEU" and incorporated herein by this reference, is hereby closed and abandoned and/or disclaimed at the request of Garden Street 28 29 Communities Southeast, LLC (the "Applicant"), subject unto 30 reservation unto City and JEA of a non-exclusive all-utilities, 31 facilities, and access easement on, over, under, through, and across

the closure area.

The Applicant has paid two closure application fees of \$4,182.00 and this sum has been deposited into the City's General Fund. This closure request was reviewed and approved by the various city, state, and utility agencies that might have an interest in the right-of-way and there were no objections to the Applicant's request.

7 Section 2. Purpose. The Applicant owns the fee parcel 8 where the closure area is located (R.E. No. 001532-0015) and has 9 requested this closure to allow for the development of a single-family 10 subdivision called Baldwin Point.

Section 3. Hold Harmless Covenant. The closure and 11 abandonment by the City of its interests in the right-of-way is 12 subject to Applicant's execution and delivery to the City of a Hold 13 14 Harmless Covenant, in substantially the same form attached hereto as Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Hold Harmless, 15 June 17, 2025 - TEU" and incorporated herein by this reference. 16 Accordingly, the closure and abandonment of the right-of-way shall 17 not be recorded in the public records until execution and delivery 18 to the City by the Applicant of the required Hold Harmless Covenant. 19

20 Section 4. Effective Date. This Ordinance shall become 21 effective upon signature by the Mayor or upon becoming effective 22 without the Mayor's signature.
