## ORDINANCE 2024-804

AN ORDINANCE APPROPRIATING \$10,000 FROM GENERAL FUND OPERATING RESERVES TO THE GENERAL FUND OPERATING, MISCELLANEOUS GRANTS AND ATDS ACCOUNT, TO PROVIDE CITY GRANT FUNDING TO THE NORTH RIVERSIDE COMMUNITY DEVELOPMENT CORPORATION ("NRCDC") TO SUPPORT ESTABLISHMENT OF THE NORTH RIVERSIDE COMMUNITY RESOURCE CENTER AS DESCRIBED HEREIN; INVOKING THE EXEMPTION IN SECTION 126.108(G) (EXEMPTIONS FROM COMPETITIVE SOLICITATION), PART 1 (GENERAL REGULATIONS; ETHICS AND TRANSPARENCY IN PUBLIC CONTRACTING), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH NRCDC; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH NRCDC; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), ORDINANCE CODE, TO ALLOW FOR ADVANCE PAYMENT TO NRCDC AS DESCRIBED HEREIN; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND NORTH RIVERSIDE COMMUNITY DEVELOPMENT

CORPORATION; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above is an appropriation of \$10,000 from General Fund Operating Reserves to the General Fund Operating, Miscellaneous Grants and Aids account, provide a City grant to North Riverside Community Development Corporation ("NRCDC") to support establishment of the North Riverside Community Resource Center in Council District 9 as described herein. Although the funds appropriated herein are from General Fund Operating Reserves, the proposed use of these funds to support programs and initiatives in Council District 9 fulfills the intent for funds previously appropriated in fiscal year 2023-2024 for Council District 9 Council Member strategic initiatives that were unencumbered and swept into the General Fund Operating Reserves on October 1, 2024.

Section 2. Purpose. The purpose of the appropriation in

Section 1 is to provide grant funds from the City of Jacksonville to NRCDC for establishment of the North Riverside Community Resource Center (the "Center") as described in **Exhibit 2**, attached hereto and incorporated herein by this reference. The Center will be located at 2955 Edison Avenue in Council District 9 and will serve the community by offering various programs, services and support including food and clothing services, educational services, housing and homelessness services, employment services, disability and community health care services, and other services. The City grant funds will be used to purchase furniture, computers and office supplies for the Center and to pay certain occupancy expenses (utilities).

Section 3. Invoking the Exemption in Section 126.108(g), Ordinance Code. The City is hereby authorized to directly procure the professional services of North Riverside Community Development Corporation for establishment of a community resource center in Council District 9 as described herein. Pursuant to Section 126.108(g) (Exemptions from competitive solicitation), Part 1 (General Regulations; Ethics and Transparency in Public Contracting), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 4. Waiver of Section 118.107, Ordinance Code. The provisions of Section 118.107 (Nonprofits to receive funding through a competitive evaluated award process), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow for a direct contract with NRCDC. This waiver is justified because NRCDC has a long-standing presence in the North Riverside community and is familiar with the unique needs of this area and the services that would benefit its residents the most.

Section 5. Waiver of Section 110.112, Ordinance Code. Section 110.112 (Advance of City funds; prohibition against), Part 1 (The City Treasury), Chapter 110 (City Treasury), Ordinance Code, is hereby waived to allow for advance payment of up to \$5,000 (50% of the total grant award amount) to North Riverside Community Development Corporation for the establishment of a community resource center as described herein.

Section 6. Approval and Authorization to Execute. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City a grant agreement with North Riverside Community Development Corporation in an amount not-to-exceed \$10,000, subject to the Term Sheet and Budget more particularly described in Exhibit 2, for a term commencing on October 1, 2024 through September 30, 2025, and all other contracts and documents, including extensions, renewals and amendments to the agreement, and to otherwise take all action necessary to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the General Counsel, or his or her designee, and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 7. Oversight Department. The Grants and Contract Compliance Division of the Finance Department shall oversee the project described herein.

Section 8. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
