ORDINANCE 2025-689-E

AN ORDINANCE APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER AN AMENDMENT TO THE FISCAL YEAR 2024-2025 CITY GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND GOODWILL OF INDUSTRIES NORTH FLORIDA, INC. "AGREEMENT"), ORIGINALLY APPROVED AND AUTHORIZED BY ORDINANCE 2024-466-E, TO EXTEND THE TERM OF THE AGREEMENT TO EXPIRE ON SEPTEMBER 30, 2026, TO EXTEND CERTAIN OTHER RELATED DATES AND DEADLINES WITHIN THE AGREEMENT, AND TO REVISE THE BUDGET AS DESCRIBED HEREIN; PROVIDING FOR CONTINUED OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2024-466-E appropriated \$785,000 authorized the Mayor, or her designee, and the Corporation Secretary, to execute, on behalf of the City, a grant agreement between the City and Goodwill Industries of North Florida, Inc. ("Goodwill"), for the Building Futures Together - A Goodwill Workforce Training Program (the "Program") for a term ending on September 30, 2025; and

WHEREAS, Goodwill has requested an extension to the term of the grant agreement through September 30, 2026, due to the unexpected delays in the buildout of their facility and initiating the Program, and has further requested certain adjustments to the approved Program

budget as further described herein; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Approval and Authorization to Execute Amendment Section 1. to Agreement. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver, an amendment to the Fiscal Year 2024-2025 City Grant Agreement between the City of Jacksonville and Goodwill Industries of North Florida, Inc. (the "Agreement"), originally approved and authorized by Ordinance 2024-466-E, to extend the term of the Agreement to September 30, 2026, to extend certain related dates and deadlines based on the extension to the term authorized herein, and to replace the Program Budget approved by Ordinance 2024-466-E with the revised Program Budget attached hereto as Exhibit 1 and incorporated herein by this reference, with all other terms and conditions of the Agreement remaining unchanged. The changes to the Program budget are summarized in more detail on Exhibit 2 attached hereto.

Section 2. Oversight. The Grants and Contract Compliance Division of the Finance Department shall continue to have oversight of the Agreement described herein.

Section 3. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that the Agreement is currently set to expire on September 30, 2025, and the Council and Goodwill want to ensure there is not a lapse in the contract term.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
