AN ORDINANCE APPROVING AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A CHILLED WATER SERVICE AGREEMENT BETWEEN JEA AND CITY OF JACKSONVILLE TO PROVIDE CHILLED WATER SERVICE TO VARIOUS CITY FACILITIES IN THE DOWNTOWN CHILLED WATER DISTRICT; PROVIDING FOR OVERSIGHT BY THE PUBLIC WORKS DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, JEA operates and maintains a district energy system in the City of Jacksonville in order to provide chilled water service to various customers (the "Service"); and

WHEREAS, the City owns and operates the following buildings and facilities, all located within Duval County, Florida: Duval County Courthouse, 501 West Adams Street; State Attorney's Office, 311 West Monroe Street; Jacksonville Public Library - Main Library, 303 North Laura Street; Library Parking Garage, 33 West Duval Street; City Hall Annex, 407 North Laura Street; and the Ed Ball Building, 214 North Hogan Street (collectively, the "Facilities"); and

WHEREAS, the Facilities currently receive Service from JEA pursuant to the Chilled Water Service Agreement Between JEA and City of Jacksonville dated August 5, 2002 (City Contract No. 7670-6), as subsequently amended; and

WHEREAS, the City and JEA desire to enter into a new agreement regarding the continued provision of Service at the Facilities which will replace and supersede the prior agreement; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Approval and Authorization to Execute. There is hereby approved, the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City a Chilled Water Service Agreement Between JEA and the City of Jacksonville for the Facilities in the Downtown Chilled Water District in substantially the form attached hereto as Exhibit 1 and incorporated herein by this reference for the continued provision of chilled water service to the Facilities.

Section 2. Oversight Department. The Department of Public Works shall oversee the administration of the agreement described herein.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
