(c) Explanation of Appropriation:

represents The funding above an appropriation \$2,474,030.29 from the General Fund Operating Fund -Interfund Transfer In account, representing returned funding related to termination of the Jacksonville International Airport Community Redevelopment Agency pursuant to Ordinance 2023-496-E, to the Starratt Road and Yellow Bluff Road Intersection Improvement - Other account, Construction Costs provide for to funds construction of improvements at the intersection of Starratt Road and Yellow Bluff Road.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funds for construction of improvements at the intersection of Starratt Road and Yellow Bluff Road. The improvements are intended to serve as a temporary solution to address traffic concerns at this intersection until a future intersection reconstruction project can be completed.

Section 3. Capital Improvement Plan Amendment. Ordinance 2024-505-E, adopting the 2025-2029 Five-Year Capital Improvement Plan (the "CIP") for the City and certain of its independent agencies, is hereby amended to reflect this appropriation of funds to the new project entitled "Starratt Road and Yellow Bluff Road Intersection Improvement" (the "Project"), as more fully described in the Project Information Sheet attached hereto as Exhibit 2 and incorporated herein by this reference. The City Council finds that the deferral of this amendment of the CIP until the next annual budget and CIP review will be detrimental to the best interests of the community because such deferral will unnecessarily delay commencement of the Project.

Section 4. Oversight. The Public Works Department shall have oversight of the Project described herein.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
