# Special Committee Proposed Amendments to the Supplemental Community Benefits Agreement

- 1. Increase the City contribution to the Eastside Strategic Focus by \$10 million (for a total of \$40 million) to be paid out over a 7-year period beginning no later than Fiscal Year 2025-26 with a minimum annual funding amount of \$4 million
- 2. Decrease the City contribution to the Countywide Strategic Focus by \$10 million (for a total of \$40 million) to be paid out over a 15-year period beginning no later than Fiscal Year 2025-26 with a minimum annual funding amount of \$2.5 million
- 3. Establishes a funding safety net that the City can delay its contributions and receive an extension of one additional year if the difference obtained by subtracting
  - (i) the City's general fund/general services district budgeted revenue in the immediately prior Fiscal Year multiplied by the greater of (A) three percent (3%), or (B) the Consumer Price Index, from
  - (ii) the amount by which the Mayor's proposed general fund/general services district budgeted revenue in such Fiscal Year exceeds the City's general fund/general services district budgeted revenue in the immediately prior Fiscal Year,

is equal to or less than \$6.5 million (the sum of the annual minimums for the Eastside and Countywide Strategic Focus)

- 4. Provide that the \$14 million for Council Districts (\$1 million per Council District) will be funded in FY 25/26, can be spent as authorized by the District Council Member for any public purpose, and will carryover to subsequent years until the funding is exhausted
- 5. Remove the TIF/CRA concept for the Eastside and instead the City agrees to explore the possibility of implementing a tax increment financing district for the Eastside
- 6. The City will be given a credit up to a maximum amount of \$5,995,001 for funds expended towards the Countywide Strategic Focus pursuant to the City's FY 24/25 budget established by Ordinance 2024-504-E
- 7. Includes a non-funding clause in the event any failure to fund the Supplemental City Financial Commitment by the City Council is not considered a default
- 8. Includes Workforce Housing as part of the Eastside and Countywide Strategic Focus' and defines affordable and workforce housing to differentiate the two

#### 2024-436 Peoples Gas Franchise - Committee Substitutes

#### **NCSPHS** substitute

- 1. Change oversight to the Finance Department.
- 2. Include waiver of applicable provisions of Chapter 711 (City Rights-of-Way) in direct conflict with proposed agreement.
- 3. Attach Revised Exhibit 1 (Agreement) to reflect negotiated agreement terms, including:
  - a. 10-year initial term with two 10-year renewal options requiring Council approval.
  - b. Future changes to City's permitting procedures will be prospectively applicable to franchisee.
  - c. Require Peoples Gas to use commercially reasonable efforts to coordinate with the City on matters impacting the rights-of-way.
  - d. 18% interest to be applied to late payments or underpayments.
  - e. Increase of franchise fee upon an increase of the same in a surrounding municipality, subsequent to City Council Approval, but no sooner than 12 months after notification from Company.
  - f. City to be compensated, up to \$20,000, for the cost of any audit finding an amount owed to the City of 5% or more in addition to interest at a rate 10% on the amount underpaid.
  - g. Waive the applicability of Chapter 711 (City Rights-of-Way).

#### **TEU** substitute

NCSPHS substitute above, plus adds:

- 5. Revise the Franchise Agreement to require Peoples Gas to provide a community notification to all property owners adjacent to where work will take place within the right-of-way which notification shall consist of the following:
  - a. Notification shall be made in the form of mailed notices, door hangers and signage at the project location.
  - b. Notification information shall include the project name, TECO/Peoples Gas contact information and the project manager's contact information.
  - c. Notification shall also include information regarding the length of the project, hours during which work will be performed, and the permit information for the project.

#### **2024-635 Journey Forward – Committee Substitutes**

#### **NCSPHS Substitute**

- 1. Include term end date for board members (September 30).
- 2. Clarify the Mayor's Office will provide administrative support to the Board.
- 3. Clarify that a copy of the adopted strategic plan will be provided to the Mayor.
- 4. Include financial information including funding appropriated and spent by program to the annual report minimum requirements.
- 5. Clarify that the agencies listed within Sec. 85.111 will receive copies of amendments to the strategic plan.
- 6. Clarify that the Mayor can make changes to the proposed budget submitted by Jacksonville Journey Forward.
- 7. Change all references from trust fund to special revenue fund.
- 8. Clarify Council appropriation is required for expenditures from the Jacksonville Journey Forward Special Revenue Fund.
- 9. Clarify due dates for the following reports to Council:
  - a. Presentation by Journey Forward Board to Rules Committee on the effectiveness of the intraagency liaison relationships: due within three months of the close of the fiscal year, with first presentation due by 12/31/25.
  - **b.** Presentation by KHA Board to Rules Committee on the effectiveness of the intra-agency liaison relationships: due within three months of the close of the fiscal year.
  - c. Ex-Offender Program annual review and recommendations by Journey Forward: due no later than December 31, with first review due by 12/31/25.
- 10. Correct scrivener's errors.
- 11. Include the Superintendent of DCPS and Chief Judge as officials who can recommend board members to the Mayor.
- 12. Remove requirement that the Grants and Contract Compliance Division present grant opportunities for review to Jacksonville Journey Forward.
- 13. Remove requirement that the Director of the Parks, Recreation and Community Services Department present contracts or programs for review by the Jacksonville Journey Forward.
- 14. Removes requirements that: 1) the Library Board of Trustees implement and incorporate feedback from the Jacksonville Journey Forward and 2) the Library Director present library contracts or programs to the Jacksonville Journey Forward for review and recommendations.
- 15. Revise Article 17 of the Charter to extend civil service system to employees of Jacksonville Journey Forward excluding executive director or professional employees.
- 16. Recitals
  - **a.** On page 3, lines 1-6 amend recital to correct historical information regarding actions leading to increases in violent crime rates after 2011.
- 17. Section 85.102 (Legislative findings and declaration) amend (3) to correct historical information regarding actions leading to a reduction in violent crime rate prior to 2011 and subsequent actions leading to an increase in violent crime rate after 2011.
- 18. Section 85.105 (Membership, organization, and meetings)
  - a. On page 6, lines 10-11 amend subsection (a) to provide that 8 members will be appointed by Mayor and confirmed by Council and 3 members will be appointed by the Council President and confirmed by Council.

- **b.** On page 6, line 22 amend subsection (a) to add "law enforcement" to list of areas of experience for board members.
- **c.** On page 6, line 31 through page 7, line 1 amend subsection (c) to provide that board members may be removed by the Mayor or City Council (whomever appointed that seat).
- 19. Section 85.103 (Jacksonville Journey Forward established) clarify intent of Jacksonville Journey Board regarding its independence.
- 20. Add requirement that the Executive Director of Jacksonville Journey Forward will be subject to confirmation by CityCouncil.
- 21. Clarify the Council President will designate a Council liaison to the Jacksonville Journey Forward Board.

#### **RULES Substitute**

NCSPHS Substitute but revises Section 85.105(a) to provide that appointments by Sheriff, State Attorney, Superintendent of DCPS, and Chief Judge will be direct appointments rather than recommendations to the Mayor for appointment (changes item 11 above).
