8 ASSISTED MASS APPRAISAL (CAMA) SYSTEM
9 SERVICES, AS INITIATED BY B.T. 21-016;
10 APPROVING AND AUTHORIZING THE MAYOR, OR HIS
11 DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE
12 AND DELIVER, FOR AND ON BEHALF OF THE CITY,
13 THAT CERTAIN SINGLE SOURCE CONTRACT BETWEEN
14 THE CITY AND MANATRON, INC., N/K/A AUMENTUM
15 TECHNOLOGIES, F/K/A THOMSON REUTERS AUMENTUM,
16 ("AUMENTUM") FOR THE PROVISION OF SERVICES
17 DESCRIBED IN THIS ORDINANCE; PROVIDING FOR
18 CITY OVERSIGHT BY THE OFFICE OF THE PROPERTY
19 APPRAISER; PROVIDING AN EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
23 within the City's budget, there is hereby appropriated the
24 indicated sum(s) from the account(s) listed in subsection (a) to
25 the account(s) listed in subsection (b):

2 (c) Explanation of Appropriation

3 The funding above is appropriating funds from within the
4 Office of the Property Appraiser's fund balance in the
5 amount of \$255,852.00 for the provision of contractual
6 services by Aumentum for fiscal year 2020-2021.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to provide funding for the provision of Computer
9 Assisted Mass Appraisal (CAMA) system services, including disaster
10 recovery and technical support services, to the Office of the
11 Property Appraiser for a three-year period beginning October 1,
12 2019 through September 30, 2022.

13 **Section 3. Approval and authorization to execute.** There
14 is hereby approved, and the Mayor, or his designee, and the
15 Corporation Secretary are hereby authorized, to execute and deliver
16 for and on behalf of the City, that certain Single Source Contract
17 between the City of Jacksonville and Manatron, Inc., n/k/a Aumentum
18 Technologies, f/k/a Thomson Reuters Aumentum (the "Contract"),
19 substantially in the form placed **On File** with the Office of
20 Legislative Services.

21 **Section 4. Oversight Department.** The Office of the
22 Property Appraiser shall oversee administration of the Contract.

23 **Section 5. Effective Date.** This ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
