5 AN ORDINANCE APPROPRIATING \$300,000 FROM THE
6 COUNCIL PRESIDENT’S DESIGNATED CONTINGENCY TO
7 THE JACKSONVILLE UPWARD MOBILITY PROGRAM SPECIAL
8 REVENUE FUND TO PROVIDE ADDITIONAL FUNDS FOR
9 VARIOUS PROGRAMS AND SERVICES AIMED AT TRAINING,
10 EDUCATING AND MAINTAINING A SUSTAINABLE LOCAL
11 WORKFORCE CONSISTENT WITH THE MISSION AND GOALS
12 FOR THE PROGRAM AS OUTLINED IN CHAPTER 180
13 (JACKSONVILLE UPWARD MOBILITY PROGRAM),
14 *ORDINANCE CODE*; AMENDING THE FOURTH REVISED
15 SCHEDULE M TO ORDINANCE 2023-511-E; PROVIDING AN
16 EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
20 within the City’s budget, there is hereby appropriated the indicated
21 sum(s) from the account(s) listed in subsection (a) to the account(s)
22 listed in subsection (b):

30 The funding above is an appropriation of \$300,000 from the
31 Council President’s Designated Contingency to the

1 Jacksonville Upward Mobility Program ("JUMP") Special
2 Revenue Fund to provide additional funding for various
3 programs and services aimed at training, educating and
4 maintaining a sustainable local workforce.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to provide additional funding for a variety of programs
7 and services aimed at training, educating and maintaining a
8 sustainable local workforce by investing in youth and young adults.
9 Funds set aside in the JUMP Special Revenue Fund are specifically
10 intended to fund new and existing apprenticeship, pre-apprenticeship
11 and workforce training programs consistent with the mission and goals
12 for the program as outlined in Chapter 180 (Jacksonville Upward
13 Mobility Program), *Ordinance Code*.

14 **Section 3. Amending Fourth Revised Schedule M to Ordinance**
15 **2023-511-E.** The Kids Hope Alliance fiscal year 2023-2024 budget
16 approved by Ordinance 2023-511-E is hereby amended by substituting
17 in the place of the Fourth Revised Schedule M, the Fifth Revised
18 Schedule M attached hereto as **Exhibit 2** and incorporated herein by
19 this reference. The Fifth Revised Schedule M reflects the funds
20 appropriated herein as well as adjustments approved by the Council
21 pursuant to Ordinance 2024-210-E.

22 **Section 4. Effective Date.** This Ordinance shall become
23 effective upon signature by the Mayor or upon becoming effective
24 without the Mayor's signature.
