7 AN ORDINANCE APPROPRIATING \$500,000 IN FUND  
8 BALANCE DERIVED FROM INVESTMENT POOL EARNINGS  
9 WITHIN THE DOWNTOWN ECONOMIC DEVELOPMENT FUND TO  
10 THE DOWNTOWN PARKS AND PROGRAMMING ACTIVITY FOR  
11 DOWNTOWN PARKS MAINTENANCE AND PROGRAMMING, AS  
12 INITIATED BY REVISED B.T. 23-074; PROVIDING AN  
13 EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
17 within the City's budget, there is hereby appropriated the indicated  
18 sum(s) from the account(s) listed in subsection (a) to the account(s)  
19 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The funding above comprises an appropriation of \$500,000  
29 in Downtown Economic Development Fund revenue consisting  
30 of Investment Pool Earnings to be allocated to the Downtown  
31 Parks and Programming Activity.

1           **Section 2.           Purpose.**   The purpose of the appropriation in  
2 Section 1 is to allocate \$500,000 in Downtown Economic Development  
3 Fund fund balance derived from Investment Pool Earnings to pay for  
4 Downtown park programming activities offered by the Parks, Recreation  
5 and Community Services Department and enhanced park maintenance. This  
6 appropriation was approved by the Downtown Investment Authority Board  
7 on March 15, 2023, pursuant to Resolution 2023-03-02, a copy of which  
8 is attached hereto as **Exhibit 2** and incorporated herein by this  
9 reference.

10           **Section 3.           Effective Date.**   This Ordinance shall become  
11 effective upon signature by the Mayor or upon becoming effective  
12 without the Mayor's signature.
