ORDINANCE CONCERNING THE AN JACKSONVILLE AVIATION AUTHORITY ("JAA") FISCAL YEAR 2021-2022 BUDGET; AMENDING REVISED SCHEDULE H (FISCAL YEAR 2021-2022 JAA CAPITAL BUDGET) OF ORDINANCE 2021-504-E (CITY OF JACKSONVILLE BUDGET ORDINANCE) BY SUBSTITUTING IN THE PLACE OF THE REVISED SECOND REVISED SCHEDULE SCHEDULE H, Α PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2021-504-E, which included the 2021-2022 Fiscal Year operating and capital budget for the Jacksonville Aviation Authority ("JAA") was enacted by Council on September 28, 2021, and became effective October 1, 2021; and

WHEREAS, a copy of the Revised Schedule H (Fiscal Year 2021-2022 Jacksonville Aviation Authority Capital Budget) approved by Ordinance 2021-504-E is Exhibit 1 ("JAA Capital Budget"); and

WHEREAS, for Fiscal Year 2021-2022, JAA will exceed the budgeted amount for capital projects by approximately \$38.6 million due to a large multi-year hangar construction project for and to be leased to a corporate tenant (the "Boeing Project"); and

WHEREAS, the Boeing Project budget has been impacted by pandemic related economic impacts including supply chain constraints and inflation, as well as customer project scope changes; and

WHEREAS, due to the increased Boeing Project costs, JAA needs to increase its capital budget appropriation for Fiscal Year 2021-2022; and

WHEREAS, on January 24, 2022, JAA approved Resolution BD2022-01-03 attached hereto as Exhibit 2, which recommended amending the JAA Capital Budget to reflect the increase to the Boeing Project costs and the new aggregate capital budget appropriation amount of \$208,702,500.00; and

WHEREAS, JAA is requesting the Council of the City of Jacksonville to approve the JAA Capital Budget amendments; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Recitals. The recitals above are incorporated herein by reference.

Aviation Authority Capital Budget) of Ordinance 2021-504-E. Sections 3.1 and 3.2 and Revised Schedule H (Jacksonville Aviation Authority Capital Budget) of Ordinance 2021-504-E are amended by substituting in the place of the Revised Schedule H, the Second Revised Schedule H attached hereto as Exhibit 3 and incorporated herein by this reference.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor, or upon becoming effective without the Mayor's signature.
