9 AN ORDINANCE APPROPRIATING \$100,974 FROM THE  
10 SOCIAL JUSTICE AND COMMUNITY INVESTMENT  
11 SPECIAL COMMITTEE CONTINGENCY FOR THE 5000  
12 ROLE MODELS OF EXCELLENCE PROJECT; AMENDING  
13 THIRD REVISED SCHEDULE M TO ORDINANCE 2020-  
14 511-E; APPROVING, AND AUTHORIZING THE MAYOR,  
15 OR HIS DESIGNEE, AND CORPORATION SECRETARY TO  
16 EXECUTE AND DELIVER, AN AGREEMENT BETWEEN THE  
17 CITY OF JACKSONVILLE AND JACKSONVILLE PUBLIC  
18 EDUCATION FUND, INC. ("JPEF"); INVOKING THE  
19 EXCEPTION IN SECTION 126.107(G), *ORDINANCE*  
20 *CODE*, TO ALLOW DIRECT CONTRACT WITH  
21 JACKSONVILLE PUBLIC EDUCATION FUND, INC. TO  
22 PROVIDE THE SERVICES FOR THE 5000 ROLE MODELS  
23 OF EXCELLENCE PROJECT; WAIVING THE

29 PROCUREMENT; PROVIDING FOR OVERSIGHT BY THE

**BE IT ORDAINED** by the Council of the City of Jacksonville:

**Section 1. Appropriation.** For the 2020-2021 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) **Explanation of Appropriation** - The funding above is being appropriated from the Social Justice and Community Investment Special Committee Contingency and to be utilized by the Jacksonville Public Education Fund, Inc. for the 5000 Role Models of Excellence project.

**Section 2. Purpose.** The purpose of the appropriation in Section 1 is to provide funding for the 5000 Role Models of Excellence project, as more fully described in **Revised Exhibit 2**, labeled as "Revised Exhibit 2, Rev Scope, June 14, 2021 - NCSPHS" attached hereto. The 5000 Role Models of Excellence project seeks to provide a sense of hope to young minority male students by offering positive visions of success to serve as a blueprint for emulation through mentorship and exposure. The project is committed to connecting students of promise to positive adult role models whose successes can inspire them to achieve.

**Section 3. Amending Third Revised Schedule M to Ordinance 2020-511-E.** There is hereby amended for the fiscal year 2020-2021 budget for the Kids Hope Alliance by substituting in the place of

1 Third Revised Schedule M, approved by Ordinance 2020-511-E, the  
2 Fourth Revised Schedule M, attached hereto as **Exhibit 3** and  
3 incorporated herein by this reference. The Fourth Revised Schedule  
4 M will reflect additional transfers and funds appropriated herein.

5 **Section 4. Agreement approved and execution authorized.**

6 There is hereby approved, and the Mayor, or his designee, and  
7 Corporation Secretary are hereby authorized to execute and deliver,  
8 the Funding Agreement between the City of Jacksonville and  
9 Jacksonville Public Education Fund, Inc., in substantially the form  
10 as attached hereto as **Revised Exhibit 4**, labeled as "Revised  
11 Exhibit 4, Rev Agmt, June 14, 2021 - NCSPHS", and incorporated  
12 herein by this reference (the "Agreement"). The Agreement may  
13 include such additions, deletions and changes as may be reasonable,  
14 necessary and incidental for carrying out the purposes thereof, as  
15 may be acceptable to the Mayor, or his designee, with such  
16 inclusion and acceptance being evidenced by execution of the  
17 Agreement by the Mayor, or his designee; provided however, no  
18 modification to the Agreement may increase the financial  
19 obligations or liability of the City to an amount in excess of the  
20 amount stated in the Agreement or decrease the duties and  
21 obligations of Jacksonville Public Education Fund, Inc., and any  
22 such modification shall be technical only and shall be subject to  
23 appropriate legal review and approval by the Office of General  
24 Counsel. For the purposes of this Ordinance, the term "technical  
25 changes" is defined as those changes having no financial impact to  
26 the City and any other non-substantive changes that do not  
27 substantively increase the duties and responsibilities of the City  
28 under the provisions of the Agreement.

29 **Section 5. Invoking the exception to Section 126.107(g),**  
30 **Ordinance Code.** The City is hereby authorized to procure the use of  
31 the professional services of Jacksonville Public Education Fund,

1 Inc., to provide services for the 5000 Role Models of Excellence  
2 project. Pursuant to Section 126.107(g) (Exemptions), Part 1  
3 (General Regulations), Chapter 126 (Procurement Code), *Ordinance*  
4 *Code*, such procurement is exempted from competitive solicitation  
5 because the supplies or services are to be provided by those  
6 specifically prescribed within authorizing legislation that  
7 appropriates the same. With the exception of the foregoing, all  
8 other provisions of Chapter 126, *Ordinance Code*, shall remain in  
9 full force and effect.

10 **Section 6. Waiving the requirements of Chapter 77 (Kids**  
11 **Hope Alliance), Section 77.111(a) (Provider Contracts), *Ordinance***  
12 ***Code*.** The City hereby waives the requirements of Chapter 77 (Kids  
13 Hope Alliance), Section 77.111(a) (Provider Contracts), *Ordinance*  
14 *Code*, with respect to the contract approved and authorized under  
15 Section 4 of this Ordinance. Section 77.111(a) requires contracts  
16 for children's services to be competitively procured by KHA via an  
17 evaluated bid process. This waiver is needed because Jacksonville  
18 Public Education Fund, Inc. is the sole provider for the 5000 Role  
19 Models of Excellence project in Duval County.

20 **Section 7. Oversight.** KHA will oversee the project and  
21 services described in Section 2 above and will ensure compliance  
22 with all other appropriate laws.

23 **Section 8. Effective Date.** This Ordinance shall become  
24 effective upon signature by the Mayor or upon becoming effective  
25 without the Mayor's signature.
