

BOYLAN FLOOR AMENDMENT #1

Council Member Boylan offers the following first Floor Amendment to File No. 2025-504:

- (1) Move \$729,556.83 from the City Budget Stabilization Contingency account to the following entities currently funded in the tentatively approved budget at \$45,000 each for services and support to the JaxCareConnect Program to fund each entity in the amount provided in the Mayor's proposed budget as follows: (1) \$166,666.66 to Agape Community Health Center, Inc. for the Interpretative Services Program, (2) \$166,666.67 to WestJax Outreach, Inc. d/b/a Community Health Outreach for the Duval County Safety Net Collaboration Program, (3) \$166,666.66 to Muslim American Social Services, Inc. for the MASS Unified Health Services Program (Duval County Safety Net Collaboration), (4) \$166,666.66 to Mission House, Inc. for the Mission House Clinic Program (Duval County Safety Net Collaboration), (5) \$166,223.52 to I.M.
