A RESOLUTION HONORING AND COMMENDING MR. DEWITT COOPER, III, FOR HIS OUTSTANDING CONTRIBUTIONS TO THE ARTS, EDUCATION, AND THE JACKSONVILLE COMMUNITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Mr. DeWitt Cooper, III, is an internationally acclaimed performer, teacher, mentor, and motivator whose passion for the arts has uplifted generations of young people in Jacksonville and beyond; and

WHEREAS, Mr. Cooper began his teaching career at Brentwood Elementary School, where he inspired young men to rise above insecurity and discover their place in the world, one of whom has gone on to become the face of the Memphis Ballet; and

WHEREAS, Mr. Cooper currently serves as a Professor of Theater and Dance at Morgan State University, while remaining deeply connected to Jacksonville through his role as Artist-in-Residence for LaVilla School of the Arts and Douglas Anderson School of the Arts, where he teaches Musical Theatre Styles and Physical Theatre; and

WHEREAS, Mr. Cooper is the Co-Founding Artistic Director of the CooperMorgan Dance Theatre, alongside noted dance empresario Savery Morgan, a creative partnership that has brought innovation, collaboration, and global recognition to the Jacksonville arts community; and

WHEREAS, Mr. Cooper's leadership and dedication have consistently elevated arts education in Jacksonville, with many of his students advancing to prestigious arts colleges and thriving as professional artists across the world; and

WHEREAS, Mr. Cooper's has extended his impact far beyond the classroom, volunteering for six years with Beaches Fine Arts to bring free world-class performances to the public, and previously serving as Artistic Director of both the Jacksonville Center for the Arts and The Posh Factory; and

WHEREAS, Mr. Cooper's academic journey reflects both discipline and distinction, having attended Florida State University as a JMI Scholar, and later Case Western Reserve University, where he earned his Master of Fine Arts in Contemporary Dance with full scholarship and stipend, becoming the first African American male to graduate with this terminal degree; and

WHEREAS, Mr. Cooper's professional excellence has been consistently recognized, including the 2017 Pelican Award for Best Choreography for *In the Heights*, induction into the 2018 Leadership Accelerator Program sponsored by Chase Bank, recognition as 2021 Adjunct Teacher of the Year, and being named 2023 Teacher of the Week by First Coast News; and

WHEREAS, in 2019, Mr. Cooper was appointed sponsor and Director of Black Arts at Douglas Anderson School of the Arts, where he founded the groundbreaking red-carpet showcase A.L.I.V.E. and launched the Legacy Project to commission a bronze statue of Douglas Anderson, ensuring a permanent monument to Black history and artistic legacy in Jacksonville; and

WHEREAS, Mr. Cooper's influence as a performer, teacher, and choreographer has reached global audiences, gracing classrooms and stages in the United States, Europe, Canada, Japan, China, and Taiwan, while simultaneously mentoring young artists who now thrive professionally on stages around the world; now therefore
