The purpose of this legislation is to seek approval from the City Council for a budget amendment to the contract with United Way of Northeast Florida, Inc. (GC-1726203/PO#701375-26)

The budget amendment is to adjust for internal restructuring of staff and roles, program needs and resources allocation. Employee Compensation will decrease by \$14,543.68. Employee Benefits will decrease by \$10,336.76. Operation Expenses will increase by \$24,881.44. There would be no change in the overall budget amount. However, because the amount being adjusted exceeds 10% above the original budget, City Council approval is required. The amendment would be retroactive to the start date of the contract which is October 1, 2025.

The City of Jacksonville entered into a contract with United Way of Northeast Florida, Inc. for the 12-month period October 1, 2025 to September 30, 2026. The contract is for the 2-1-1 program.
