## **ORDINANCE 2024-930**

AN ORDINANCE REGARDING APPOINTMENTS TO THE GOVERNING BODY OF JEA; AMENDING SECTION 21.03 (COMPOSITION; COMPENSATION; OFFICERS; MEETINGS), ARTICLE 21 (JEA), CITY CHARTER, TO ALLOW A LIMITED EXCEPTION TO THE REQUIREMENT THAT MEMBERS APPOINTED TO THE GOVERNING BODY OF JEA BE RESIDENTS AND ELECTORS OF THE CITY TO PROVIDE THAT ONE MEMBER APPOINTED BY THE MAYOR AND CONFIRMED BY COUNCIL AND ONE MEMBER NOMINATED BY THE COUNCIL PRESIDENT AND CONFIRMED BY COUNCIL MAY RESIDE OUTSIDE THE CITY BUT MUST EITHER RESIDE WITHIN THE JEA SERVICE TERRITORY OR MAINTAIN A SUBSTANTIAL ECONOMIC BUSINESS INTEREST WITHIN THE JEA SERVICE TERRITORY AS DETERMINED BY THE CITY COUNCIL; PROVIDING FOR CODIFICATION INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.

Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare): This Ordinance amends the Jacksonville City Charter pertaining to appointments to the JEA Board. It authorizes the appointment of up to two members who are not residents or electors of Duval County but who either reside in the JEA service area or who maintain a substantial business interest in the JEA service area. This serves the public welfare by expanding the opportunity to identify and appoint the most qualified members to serve on the JEA Board.
