5 AN ORDINANCE AUTHORIZING THE GRANTING OF A
6 NON-RESIDENTIAL SOLID WASTE COLLECTION AND
7 TRANSPORTATION FRANCHISE TO JACKSONVILLE
8 DUMPSTER, LLC D/B/A BIN THERE DUMP THAT
9 PURSUANT TO CHAPTER 380 (SOLID WASTE
10 MANAGEMENT), PART 6 (NONRESIDENTIAL SOLID
11 WASTE COLLECTION AND TRANSPORTATION
12 FRANCHISES), *ORDINANCE CODE*; PROVIDING FOR
13 OVERSIGHT BY THE SOLID WASTE DIVISION OF THE
14 DEPARTMENT OF PUBLIC WORKS; PROVIDING AN
15 EFFECTIVE DATE.

17 **WHEREAS**, Jacksonville Dumpster, LLC d/b/a Bin There Dump That
18 has submitted an application for a non-residential solid waste
19 collection and transportation franchise pursuant to the provisions
20 of Chapter 380, *Ordinance Code*; and

21 **WHEREAS**, the application was reviewed by the Solid Waste
22 Division of the Department of Public Works; and

23 **WHEREAS**, the Department of Public Works recommends granting a
24 franchise for non-residential solid waste collection and
25 transportation to Jacksonville Dumpster, LLC; and

26 **WHEREAS**, granting a non-residential solid waste collection and
27 transportation franchise to Jacksonville Dumpster, LLC will further
28 the purposes for which the franchise program was adopted,
29 including, but not limited to, safeguarding public health, safety,
30 and welfare in the collection and transportation of solid waste
31 through Jacksonville; now therefore

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1. Franchise agreement authorized.** In accordance
3 with the provisions of Chapter 380 (Solid Waste Management), Part 6
4 (Nonresidential Solid Waste Collection and Transportation
5 Franchises), *Ordinance Code*, the Director of the Public Works
6 Department is hereby authorized to issue a franchise agreement to
7 Jacksonville Dumpster, LLC to collect and transport non-residential
8 solid waste in the City of Jacksonville. Jacksonville Dumpster, LLC
9 has paid the application fee of \$1,500.00. A copy of the Non-
10 residential Solid Waste Collection and Transportation Franchise
11 Agreement is attached hereto as **Exhibit 1** and incorporated herein
12 by this reference. A copy of the letter from the Department of
13 Public Works forwarding Jacksonville Dumpster, LLC's application to
14 the Council for action is attached hereto as **Exhibit 2** and
15 incorporated herein by this reference.

16 **Section 2. Oversight.** The Solid Waste Division of the
17 Department of Public Works shall oversee the project described
18 herein.

19 **Section 3. Effective Date.** This ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
