Ordinance 2024-507-E is hereby further amended by including the revised Grant Application Solution project information sheet, attached hereto as **Exhibit 3** and incorporated herein by this reference, as part of Exhibit 2 to Ordinance 2024-507-E.";

- (8) Renumber the remaining Section accordingly;
- (9) Remove **Exhibit 1** and replace with **Second Revised Exhibit 1**, attached hereto, which attaches the second revised B.T. to correct account information and reflect the increased appropriation amount;
- (10) Attach a new **Exhibit 2**, attached hereto, which attaches the revised Fiscal Year 2025-2029 IT System Development Projects schedule to reflect a reduction in funding for the Grant Application Solution project;
- (11) Attach a new **Exhibit 3**, attached hereto, which attaches the revised Grant Application Solution project information sheet to reflect the reduced funding for the project;
- (12) On **page 1, line 1,** amend the introductory sentence to add that the bill was amended as reflected herein.
