6 AN ORDINANCE CONCERNING THE CITY OF JACKSONVILLE
7 SAFETY AND CRIME REDUCTION COMMISSION; AMENDING
8 SECTION 78.107 (SUNSET PROVISION), CHAPTER 78
9 (SAFETY AND CRIME REDUCTION COMMISSION),
10 *ORDINANCE CODE*, TO PROVIDE FOR SUNSET OF THE
11 COMMISSION ON DECEMBER 31, 2024; PROVIDING FOR
12 CODIFICATION INSTRUCTIONS; PROVIDING AN
13 EFFECTIVE DATE.

15 **WHEREAS**, pursuant to Section 78.107, *Ordinance Code*, the
16 Safety and Crime Reduction Commission (the "Commission") is currently
17 scheduled to sunset on July 1, 2025, unless further extended by
18 Council action; and

19 **WHEREAS**, a review of the current progress of the Commission,
20 including all outstanding funded grant obligations and other pending
21 contracts has been conducted to ascertain whether the aforementioned
22 sunset date would be appropriate; and

23 **WHEREAS**, the Council desires to acknowledge and applaud the
24 success of the Commission and the current and former slate of
25 Commissioners and affiliated former Council Members in carrying out
26 the mission and purpose for which the Commission was established as
27 outlined in Section 78.101, *Ordinance Code*, and has determined it
28 appropriate and in the City's and Commission's best interests to
29 adjust the sunset date of the Commission to occur on December 31,
30 2024; now therefore

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1 **Section 1. Amending Section 78.107 (Sunset Provision),**
2 **Chapter 78 (Safety and Crime Reduction Commission), Ordinance Code.**
3 Section 78.107 (Sunset Provision), Chapter 78 (Safety and Crime
4 Reduction Commission), *Ordinance Code*, is hereby amended to read as
5 follows:

6 **CHAPTER 78 - SAFETY AND CRIME REDUCTION COMMISSION**

7 *** * ***

8 **Sec. 78.107. - Sunshine Provision.**

9 This ~~Chapter~~~~Section~~ shall sunset on December 31, 2024, ~~July 1,~~
10 ~~2025~~ unless, prior to the Sunset date, the City Council shall pass
11 legislation to extend the Commission.

12 **Section 2. Codification Instructions.** The Codifier and the
13 Office of General Counsel are authorized to make all chapter and
14 division "tables of contents" consistent with the changes set forth
15 herein. Such editorial changes and any others necessary to make the
16 *Ordinance Code* consistent with the intent of this legislation are
17 approved and directed herein, and changes to the *Ordinance Code* shall
18 be made forthwith and when inconsistencies are discovered.

19 **Section 3. Effective Date.** This Ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
