10 TWO (2) NEW FULL-TIME POSITIONS WITHIN THE
11 SUPERVISOR OF ELECTIONS OFFICE, AS INITIATED BY
12 B.T. 24-105; APPROVING POSITIONS, AS INITIATED
13 BY R.C. 24-134; PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
17 within the City's budget, there are hereby appropriated the indicated
18 sum(s) from the account(s) listed in subsection (a) to the account(s)

27 The funding above represents a transfer of \$110,225.00
28 within the General Fund - SERE Registration - Other
29 Governmental Activity to provide salaries and benefits for
30 two (2) new full-time positions within the Supervisor of
31 Elections office.

1 **Section 2. Purpose.** The purpose of the appropriation in
2 Section 1 is to provide funding for one (1) full-time Assistant
3 Elections Officer - Military Affairs/Vote-By-Mail position and one
4 (1) Assistant Elections Officer - Voting Systems Developer position
5 within the Supervisor of Elections office, who will perform the job
6 tasks previously performed by part-time employees.

7 The Supervisor of Elections has eliminated sixteen (16) part-
8 time positions. These funds will be reallocated to fund the full-time
9 positions.

10 **Section 3. Approval of Positions.** There is approved the
11 positions more fully described in R.C. 24-134, attached hereto as
12 **Exhibit 2** and incorporated herein by this reference.

13 **Section 4. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
