AN ORDINANCE APPROPRIATING \$35,000.00 IN GRANT
FUNDING FOR YEAR ONE OF A THREE-YEAR GRANT FROM
THE COMMUNITY FOUNDATION FOR NORTHEAST FLORIDA
TO PROVIDE MENTAL HEALTH, LIFE SKILLS COACHING,
AND DRUG TREATMENT SERVICES FOR DUVAL COUNTY
TEEN COURT PROGRAM PARTICIPANTS, AS INITIATED BY
B.T. 25-080; PROVIDING FOR CARRYOVER OF FUNDS TO
FISCAL YEAR 2025-2026; PROVIDING FOR OVERSIGHT
AND REPORTING BY THE COURT ADMINISTRATION,
DIRECTOR OF TEEN COURTS; PROVIDING AN EFFECTIVE
DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year,
within the City's budget, there is hereby appropriated the indicated

(c) Explanation of Appropriation:

The funding above is an appropriation of grant funds from
the Community Foundation for Northeast Florida for year 1

1 of a three-year grant to provide certain services to Duval
2 County Teen Court program participants. The grant period
3 commenced on March 29, 2025, and continues through February
4 28, 2028. No local match is required.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to provide funding for mental health, life skills
7 coaching, and drug treatment services to Duval County Teen Court
8 program participants. This grant funding helps to cover the gap in
9 funding for these critical services. A copy of the Community
10 Foundation for Northeast Florida Grant Contract providing the terms
11 and conditions for the grant is attached hereto as **Exhibit 2** and
12 incorporated herein by this reference.

13 **Section 3. Carryover.** The funds appropriated in this
14 Ordinance shall not lapse but shall carryover to fiscal year
15 2025-2026.

16 **Section 4. Oversight and Reporting.** The Court
17 Administration, Director of Teen Courts shall provide oversight of
18 the grant described herein and shall also be responsible to provide
19 grant activity reports to the Community Foundation for Northeast
20 Florida in accordance with the terms of the grant.

21 **Section 5. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
