4 **ORDINANCE 2020-382-E**

5 AN ORDINANCE ADOPTING A SMALL-SCALE AMENDMENT
6 TO THE FUTURE LAND USE MAP SERIES OF THE 2030
7 *COMPREHENSIVE PLAN* BY CHANGING THE FUTURE LAND
8 USE DESIGNATION FROM LOW DENSITY RESIDENTIAL
9 (LDR) TO CONSERVATION (CSV) ON APPROXIMATELY
10 9.58± ACRES LOCATED IN COUNCIL DISTRICT 10 AT
11 6102 OLD KINGS ROAD AND 6156 OLD KINGS ROAD,
12 BETWEEN PICKETTVILLE ROAD AND PRITCHARD ROAD,
13 OWNED BY FLOYD J. WARWICK, JR., AND WARWICK JAX
14 PROPERTIES, LLC, AS MORE PARTICULARLY DESCRIBED
15 HEREIN, PURSUANT TO APPLICATION NUMBER L-5439-
16 20C; PROVIDING A DISCLAIMER THAT THE AMENDMENT
17 GRANTED HEREIN SHALL NOT BE CONSTRUED AS AN
18 EXEMPTION FROM ANY OTHER APPLICABLE LAWS;
19 PROVIDING AN EFFECTIVE DATE.

21 **WHEREAS**, pursuant to the provisions of Section 659.582(b),
22 *Ordinance Code*, and Section 163.3187(1), *Florida Statutes*, an
23 application for a proposed Small-Scale Amendment to the Future Land
24 Use Map series (FLUMs) of the *2030 Comprehensive Plan* to change the
25 Future Land Use designation from Low Density Residential (LDR) to
26 Conservation (CSV) on 9.58± acres of certain real property in
27 Council District 10, was filed by the City of Jacksonville, on
28 behalf of the owners, Floyd J. Warwick, Jr., and Warwick Jax
29 Properties, LLC; and

30 **WHEREAS**, the Planning and Development Department reviewed the
31 proposed revision and application and has prepared a written report

1 and rendered an advisory recommendation to the City Council with
2 respect to the proposed amendment; and

3 **WHEREAS**, the Planning Commission, acting as the Local Planning
4 Agency (LPA), held a public hearing on this proposed amendment,
5 with due public notice having been provided, reviewed and
6 considered comments received during the public hearing and made its
7 recommendation to the City Council; and

8 **WHEREAS**, the Land Use and Zoning (LUZ) Committee of the City
9 Council held a public hearing on this proposed amendment to the
10 *2030 Comprehensive Plan*, pursuant to Chapter 650, Part 4, *Ordinance*
11 *Code*, considered all written and oral comments received during the
12 public hearing, and has made its recommendation to the City
13 Council; and

14 **WHEREAS**, the City Council held a public hearing on this
15 proposed amendment, with public notice having been provided,
16 pursuant to Section 163.3187, *Florida Statutes* and Chapter 650,
17 Part 4, *Ordinance Code*, and considered all oral and written
18 comments received during public hearings, including the data and
19 analysis portions of this proposed amendment to the *2030*
20 *Comprehensive Plan* and the recommendations of the Planning and
21 Development Department, the Planning Commission and the LUZ
22 Committee; and

23 **WHEREAS**, in the exercise of its authority, the City Council
24 has determined it necessary and desirable to adopt this proposed
25 amendment to the *2030 Comprehensive Plan* to preserve and enhance
26 present advantages, encourage the most appropriate use of land,
27 water, and resources consistent with the public interest, overcome
28 present deficiencies, and deal effectively with future problems
29 which may result from the use and development of land within the
30 City of Jacksonville; now, therefore

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1 **Section 1. Purpose and Intent.** This Ordinance is adopted
2 to carry out the purpose and intent of, and exercise the authority
3 set out in, the Community Planning Act, Sections 163.3161 through
4 163.3248, *Florida Statutes*, and Chapter 166, *Florida Statutes*, as
5 amended.

6 **Section 2. Subject Property Location and Description.**
7 The approximately 9.58± acres (R.E. Nos. 083578-0000 (portion) and
8 083578-0010 (portion)) are located in Council District 10 at 6102
9 Old Kings Road and 6156 Old Kings Road, between Pickettville Road
10 and Pritchard Road, as more particularly described in **Exhibit 1**,
11 dated March 19, 2020, and graphically depicted in **Exhibit 2**, both
12 **attached hereto** and incorporated herein by this reference (Subject
13 Property).

14 **Section 3. Owner and Applicant Description.** The Subject
15 Property is owned by Floyd J. Warwick, Jr., and Warwick Jax
16 Properties, LLC. The applicant is the City of Jacksonville, 214
17 North Hogan Street, Suite 300, Jacksonville, Florida 32202; (904)
18 255-7800.

19 **Section 4. Adoption of Small-Scale Land Use Amendment.**
20 The City Council hereby adopts a proposed Small-Scale revision to
21 the Future Land Use Map series of the *2030 Comprehensive Plan* by
22 changing the Future Land Use Map designation from Low Density
23 Residential (LDR) to Conservation (CSV), pursuant to Application
24 Number L-5439-20C.

25 **Section 5. Applicability, Effect and Legal Status.** The
26 applicability and effect of the *2030 Comprehensive Plan*, as herein
27 amended, shall be as provided in the Community Planning Act,
28 Sections 163.3161 through 163.3248, *Florida Statutes*, and this
29 Ordinance. All development undertaken by, and all actions taken in
30 regard to development orders by governmental agencies in regard to
31 land which is subject to the *2030 Comprehensive Plan*, as herein

1 amended, shall be consistent therewith as of the effective date of
2 this amendment to the plan.

3 **Section 6. Effective date of this Plan Amendment.**

4 (a) If the amendment meets the criteria of Section 163.3187,
5 *Florida Statutes*, as amended, and is not challenged, the effective
6 date of this plan amendment shall be thirty-one (31) days after
7 adoption.

8 (b) If challenged within thirty (30) days after adoption, the
9 plan amendment shall not become effective until the state land
10 planning agency or the Administration Commission, respectively,
11 issues a final order determining the adopted Small-Scale Amendment
12 to be in compliance.

13 **Section 7. Disclaimer.** The amendment granted herein shall
14 **not** be construed as an exemption from any other applicable local,
15 state, or federal laws, regulations, requirements, permits or
16 approvals. All other applicable local, state or federal permits or
17 approvals shall be obtained before commencement of the development
18 or use and issuance of this amendment is based upon
19 acknowledgement, representation and confirmation made by the
20 applicant(s), owner(s), developer(s) and/or any authorized agent(s)
21 or designee(s) that the subject business, development and/or use
22 will be operated in strict compliance with all laws. Issuance of
23 this amendment does **not** approve, promote or condone any practice or
24 act that is prohibited or restricted by any federal, state or local
25 laws.

26 **Section 8. Effective Date.** This Ordinance shall become
27 effective upon signature by the Mayor or upon becoming effective
28 without the Mayor's signature.
