10 PROGRAMS, ADMINISTERED BY THE STATE OF FLORIDA  
11 AGENCY FOR HEALTH CARE ADMINISTRATION, TO FUND  
12 THE ACQUISITION OF CERTAIN FIRE APPARATUS AND  
13 REPLACEMENT CAPITAL EQUIPMENT AND TO FUND  
14 ADDITIONAL PERSONNEL COSTS TO CONVERT ONE  
15 PART-TIME FIRE/RESCUE EMS BILLING AND CODING  
16 SPECIALIST POSITION TO A FULL-TIME EMS BILLING  
17 AND CODING SPECIALIST POSITION WITHIN THE  
18 JACKSONVILLE FIRE AND RESCUE DEPARTMENT, AS  
19 INITIATED BY REVISED B.T. 21-036; AUTHORIZING  
20 SAID POSITION, AS INITIATED BY R.C. 21-061;

24 **Section 1. Appropriation.** For the 2020-2021 fiscal year,

(c) Explanation of Appropriation:

The funding above represents a transfer of unbudgeted revenue from the Fiscal Year 2019-2020 Managed Care Options ("MCO") and Certified Public Expenditures ("CPE") Medicaid Programs, administered by the State of Florida Agency for Health Care Administration, to the Jacksonville Fire and Rescue Department. No local match is required.

**Section 2. Purpose.** The purpose of the appropriation in Section 1 is to fund the acquisition of certain fire apparatus and replacement capital equipment lost in a ship fire, and additional personnel costs for the conversion of one part-time EMS Billing and Coding Specialist position to a full-time EMS Billing and Coding Specialist position within the Jacksonville Fire and Rescue Department to assist with the recapture of MCO/CPE funds and Medicare ground ambulance data collection. Ongoing maintenance will be required for the fire apparatus and equipment replacement items.

**Section 3. Authorization of Position.** There is hereby authorized the position more fully described in R.C. 21-061, attached hereto as **Exhibit 2** and incorporated herein by this reference.

**Section 4. Effective Date.** This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
