16 **Section 1. Appropriation.** For the 2024-2025 fiscal year,

27 The funding above represents an appropriation of
28 \$141,013.31 from various accounts within the Building
29 Inspection Fund (15104), including the Contractual
30 Services account (\$14,240.85), the Hardware - Software
31 Maintenance and Licenses account (\$28,497.20), the

Miscellaneous Services and Charges account (\$17,912.50), the Clothing, Uniforms, and Safety Equipment account (\$8,219.01), the Other Operating Supplies account (\$8,767.84), the Software, Computer Items Under \$5,000 account (\$4,060.04), the Dues and Subscriptions account (\$3,599.00), and the Other Professional Services account (\$55,716.87), to fund part-time hours for the Building Inspection Division of the Public Works Department.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for part-time hours within the Building Inspection Division of the Public Works Department for the remainder of fiscal year 2024-2025.

Section 3. Approval of Part-Time Hours. There is hereby approved part-time hours as more fully described in R.C. 25-166, attached hereto as **Exhibit 2** and incorporated herein by this reference.

Section 4. Oversight Department. The Building Inspection Division of the Public Works Department shall provide oversight of the part-time hours described herein

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
