5 **ORDINANCE 2022-688**

6 AN ORDINANCE APPROPRIATING \$150,000.00 FROM A  
7 DESIGNATED SPECIAL COUNCIL CONTINGENCY TO  
8 PROVIDE FUNDING FOR THE CITY OF JACKSONVILLE'S  
9 CONTRIBUTION TO THE NORTHEAST FLORIDA FIRE WATCH  
10 COUNCIL; REQUESTING ONE CYCLE EMERGENCY PASSAGE;  
11 PROVIDING FOR OVERSIGHT; PROVIDING AN EFFECTIVE  
12 DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
16 within the City's budget, there are hereby appropriated the indicated  
17 sum(s) from the account(s) listed in subsection (a) to the account(s)  
18 listed in subsection (b):

25 (c) **Explanation of Appropriation** - Transfer funding from the  
26 designated Council contingency for Jacksonville's  
27 contribution to the Northeast Florida Fire Watch Council.

28 **Section 2. Purpose.** The purpose of the appropriation in  
29 Section 1 above is to provide funding from the City of Jacksonville  
30 to the Northeast Florida Fire Watch Council as part of the Duval  
31 County's contribution to help reduce veteran suicide.

1           **Section 3.           Requesting one cycle emergency passage pursuant**  
2 **to Council Rule 4.901 Emergency.** Once cycle emergency passage of this  
3 legislation is requested. The nature of the emergency is that this  
4 funding was recommended by the Finance Committee meeting at their  
5 August 26 budget meeting. The funding was not included in the budget  
6 amendments to Ordinance 2022-504 due to a conflict of interest for a  
7 Council Member which would result. Emergency action is requested so  
8 that this bill can be taken up in conjunction with Ordinance 2022-  
9 504 and approved as part of the City's budget package.

10           **Section 4.           Oversight Department.** The Office of Grants and  
11 Contract Compliance within the Department of Finance and  
12 Administration shall oversee the project described herein.

13           **Section 5.           Effective Date.** This Ordinance shall become  
14 effective upon signature by the Mayor or upon becoming effective  
15 without the Mayor's signature.
