4 **ORDINANCE 2023-606-E**

5 AN ORDINANCE APPROPRIATING \$90,000.00 FROM
6 DESIGNATED SPECIAL COUNCIL CONTINGENCY TO
7 PROVIDE FUNDING FOR THE CITY OF JACKSONVILLE'S
8 CONTRIBUTION TO THE NORTHEAST FLORIDA FIRE WATCH
9 COUNCIL; REQUESTING ONE CYCLE EMERGENCY PASSAGE;
10 PROVIDING FOR OVERSIGHT BY THE GRANTS AND
11 CONTRACT COMPLIANCE DIVISION; PROVIDING AN
12 EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
16 within the City's budget, there are hereby appropriated the indicated
17 sum(s) from the account(s) listed in subsection (a) to the account(s)
18 listed in subsection (b):

25 (c) Explanation of Appropriation - The appropriation above is
26 a transfer of funding from designated Special Council
27 Contingency for the City of Jacksonville's contribution to
28 the Northeast Florida Fire Watch Council.

29 **Section 2. Purpose.** The purpose of the appropriation in
30 Section 1 above is to provide funding from the City of Jacksonville
31 to the Northeast Florida Fire Watch Council. This funding serves as

1 Duval County's fiscal year 2023-2024 contribution to help further the
2 mission of the Northeast Florida Fire Watch Council to reduce veteran
3 suicide.

4 **Section 3. Requesting One Cycle Emergency Passage Pursuant**
5 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
6 legislation is requested. The nature of the emergency is that this
7 funding was recommended by Council Members White, Arias, Carrico,
8 Gaffney, Jr., and Pittman during the August 25, 2023, budget meeting
9 of the Finance Committee. This funding was not included in the
10 amendments to Ordinance 2023-504 due to a conflict of interest that
11 would arise for a Council Member. Emergency action is requested so
12 that this legislation can be taken up in conjunction with Ordinance
13 2023-504 and approved as part of the City's budget package.

14 **Section 4. Oversight Department.** The Grants and Contract
15 Compliance Division within the Department of Finance and
16 Administration shall oversee the grant described herein.

17 **Section 5. Effective Date.** This Ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
