16 WHEREAS, CWR Commonwealth Refuse, LLC ("CWR") has submitted an 17 application for a non-residential solid waste collection and 18 transportation franchise pursuant to the provisions of Chapter 380, 19 Part 6, Jacksonville Ordinance Code; and

20 WHEREAS, the application was reviewed by the Solid Waste 21 Division of the Office of Administrative Services; and

22 WHEREAS, the Office of Administrative Services recommends 23 granting a franchise for non-residential solid waste collection and 24 transportation to CWR; and

WHEREAS, granting a non-residential solid waste collection and transportation franchise to CWR will further the purpose for which the franchise program was adopted, including, but not limited to, safeguarding public health, safety and welfare in the collection and transportation of solid waste through Jacksonville; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:
Section 1. Franchise Agreement authorized. In accordance

with the provisions of Part 6 (Nonresidential Solid Waste Collection 1 2 and Transportation Franchises), Chapter 380 (Solid Waste Management), 3 Jacksonville Ordinance Code, the Manager of the Office of Administrative Services is hereby authorized to issue a franchise 4 5 agreement to CWR Commonwealth Refuse, LLC for collection and transportation of non-residential solid waste in the City of 6 7 Jacksonville. CWR has paid the application fee of \$1,500.00. A copy of the Non-Residential Solid Waste Collection and Transportation 8 9 Franchise Agreement is attached hereto as **Exhibit 1** and incorporated 10 herein by this reference. A copy of the letter from the Office of 11 Administrative Services forwarding CWR's application to the Council for action is attached hereto as **Exhibit 2** and incorporated herein 12 by this reference. 13

14 Section 2. Oversight. The Solid Waste Division of the 15 Office of Administrative Services shall oversee the franchise 16 described herein.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
