5 AN ORDINANCE AMENDING PART 16 (TRUCK ROUTE
6 REGULATIONS), CHAPTER 804 (JACKSONVILLE
7 TRAFFIC CODE), ORDINANCE CODE, TO AMEND
8 SECTION 804.1607 (CERTAIN DUMP TRUCKS
9 PROHIBITED) TO PROHIBIT OPERATORS OF DUMP
10 TRUCKS WITH 10 OR MORE WHEELS FROM DRIVING ON,
11 TRAVELING OVER OR USING THAT PORTION OF
12 ROADWAYS FROM THE NORTHERNMOST POINT OF SAWPIT
13 ROAD TO CEDAR POINT ROAD, WEST ON CEDAR POINT
14 ROAD TO GROVER ROAD, AND REMOVING THE
15 PROHIBITION ON THE REMAINING PORTION OF CEDAR
16 POINT ROAD WEST AND SOUTH ON NEW BERLIN ROAD
17 UNTIL ITS TERMINATION AT HECKSCHER DRIVE IN
18 JACKSONVILLE, AND ADDING AN EXEMPTION FOR
19 PROPERTY OWNERS USING THOSE ROADWAYS AS THEIR
20 SOLE MEANS OF INGRESS AND EGRESS TO PROPERTY;
21 PROVIDING FOR AN EFFECTIVE DATE.

23 **Section 1. Amending Part 16 (Truck Route Regulations),**
24 **Section 804.1607 (Certain Dump Trucks Prohibited), Chapter 804**
25 **(Jacksonville Traffic Code), Ordinance Code.** Part 16 (Truck Route
26 Regulations), Chapter 804 (Jacksonville Traffic Code), *Ordinance*
27 *Code*, is hereby amended to read as follows:

28 **CHAPTER 804. JACKSONVILLE TRAFFIC CODE.**

30 **PART 16. TRUCK ROUTE REGULATIONS**

1 * * *

2 **Sec. 804.1607 - Certain Dump Trucks Prohibited.**

3 (a) Operators of Dump Trucks having ten or more wheels are
4 hereby prohibited from traveling over, driving on or
5 using that portion of roadways from the northernmost
6 point of Sawpit Road, south to Cedar Point Road, west on
7 Cedar Point Road to ~~New Berlin Road~~ Grover Road in
8 Jacksonville. This prohibition shall not apply to any
9 Dump Truck that is legally stored on and operated from
10 any property that is owned or leased by the vehicle owner
11 in an area where any roadway identified in this section
12 provides the sole means of ingress or egress.

13 (b) The Jacksonville Sheriff's Office shall enforce this
14 Section in accordance with the provisions of Section
15 804.1606, Ordinance Code, provided a warning shall be
16 issued for six months after enactment of this Section.

18 **Section 2. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
