BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2018-2019 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the accounts(s) listed in subsection (b):

(c) Explanation of Appropriation

The funding above is from the State of Florida, Child Support Enforcement Division for the service of process by the Civil Process Unit of the Jacksonville Sheriff's Office (JSO) for child support cases.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding from the State of Florida Child Support Enforcement Division to JSO to offset the salary expenses of both part-time and full-time authorized employees in the Civil Process Unit for the period September 1, 2019 through August 31, 2024.

Section 3. Authorization. There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to (i) execute and deliver, for and on behalf of the City, the State of Florida Department of Revenue - Child Support Standard Contract between the Duval County Sheriff's Office and the Florida Department of Revenue ("DOR") for the service of process in

1 the DOR Child Support Enforcement Program, in substantially the
2 same form placed **ON FILE** with the Office of Legislative Services,
3 and other documents necessary or appropriate to effectuate the
4 purpose of this ordinance and (ii) take, or cause to be taken, for
5 and on behalf of the City, such further action to effectuate the
6 purpose of this ordinance.

7 **Section 4. Effective Date.** This ordinance shall become
8 effective upon signature by the Mayor or upon becoming effective
9 without the Mayor's signature.
