

BUSINESS IMPACT ESTIMATE

Ordinance Title: AN ORDINANCE REGARDING DOWNTOWN SIDEWALKS AND BARS; AMENDING SECTION 154.108 (CONSUMPTION ON VENDER'S PREMISES), PART 1 (IN GENERAL), CHAPTER 154 (ALCOHOLIC BEVERAGES), ORDINANCE CODE, TO EXPAND THE PREMISES AREA; AMENDING SECTION 250.801 (DEFINITIONS), PART 8 (DOWNTOWN SIDEWALK CAFES), CHAPTER 250 (MISCELLANEOUS BUSINESS REGULATIONS), ORDINANCE CODE, TO EXPAND THE DOWNTOWN AREAS FOR SIDEWALK CAFES AND BARS; PROVIDING FOR CODIFICATION; PROVIDING AN EFFECTIVE DATE.

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare):
The ordinance will expand 1) the physical location that sidewalk cafes, restaurants and bars can serve customers on the sidewalk and in certain circumstances, such as sidewalk enhancement areas and parklets, and 2) the areas downtown for bars the serve outside beyond E-Town. The public purpose is to encourage a more vibrant downtown.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City of Jacksonville, if any:
