4 **ORDINANCE 2023-134**

5 AN ORDINANCE ADOPTING A MODIFICATION TO THE CITY  
6 OF JACKSONVILLE *2030 COMPREHENSIVE PLAN* FOR THE  
7 PURPOSE OF UPDATING THE FIVE-YEAR CAPITAL  
8 IMPROVEMENTS SCHEDULE OF PROJECTS WITHIN THE  
9 CAPITAL IMPROVEMENTS ELEMENT; PROVIDING AN  
10 EFFECTIVE DATE.

12 **WHEREAS**, a modification to the Five-Year Capital Improvements  
13 Element Schedule of Projects, contained in the Capital Improvements  
14 Element of the City of Jacksonville *2030 Comprehensive Plan*, has been  
15 initiated by the Planning and Development Department, which  
16 modification is more particularly set forth in **Exhibit 1**, attached  
17 hereto; and

18 **WHEREAS**, on September 27, 2022, the City Council approved  
19 Ordinance 2022-505-E, adopting the Fiscal Years 2023-2027 Capital  
20 Improvements Plan (the "CIP"), and the Capital Improvements Element  
21 Schedule of Projects is a subset of the City's approved CIP; and

22 **WHEREAS**, projects within the Capital Improvements Element  
23 Schedule may be funded by local, regional, state or federal  
24 governments, or may be privately funded, and therefore, the Capital  
25 Improvements Element Schedule includes projects from the North  
26 Florida Transportation Planning Organization's Transportation  
27 Improvement Plan and Long Range Transportation Plan, as well as the  
28 City of Jacksonville's Mobility System Projects; and

29 **WHEREAS**, pursuant to Section 163.3177(3) (b), *Florida Statutes*,  
30 the City of Jacksonville may modify the *2030 Comprehensive Plan* to  
31 update the Five-Year Capital Improvements Element Schedule of

1 Projects by ordinance, and such modification is not deemed an  
2 amendment to the *2030 Comprehensive Plan*; now, therefore

3 **BE IT ORDAINED** by the Council of the City of Jacksonville:

4 **Section 1. Modification to the Capital Improvements Element**  
5 **of the City of Jacksonville 2030 Comprehensive Plan.** The Capital  
6 Improvements Element of the City of Jacksonville *2030 Comprehensive*  
7 *Plan* is hereby modified to update the Five-Year Capital Improvements  
8 Element Schedule of Projects within the Capital Improvements Element,  
9 as more particularly set forth in **Exhibit 1**, attached hereto. The  
10 Planning and Development Department is hereby authorized to include  
11 all updates to the Capital Improvement Plan approved by the City  
12 Council, through the date of enactment of this Ordinance, in the  
13 Capital Improvements Element Schedule, and shall place the final  
14 Capital Improvements Element Schedule in the file with the City  
15 Council Legislative Services Division, and upon confirmation of  
16 Americans with Disabilities Act (ADA) compliance, shall publish the  
17 final Capital Improvements Element Schedule on the City's website as  
18 part of the Capital Improvements Element of the *2030 Comprehensive*  
19 *Plan*.

20 **Section 2. Effective Date.** This Ordinance shall become  
21 effective upon signature by the Mayor or upon becoming effective  
22 without the Mayor's signature.
