ALONG THE NORTH LINE OF SAID OWENS ROAD, TO THE POINT OF BEGINNING; THENCE NORTH 00°25'27" WEST, 2431.56 FEET; THENCE SOUTH 88°50'31" WEST, 312.99 FEET; THENCE NORTH 00°29'46" WEST, 770.02 FEET; THENCE NORTH 88°50'31" EAST, 2723.68 FEET, TO THE WEST LINE OF I-95 (A 300.0 FOOT LIMITED ACCESS RIGHT- OF- WAY); THENCE SOUTH 22°04'17" WEST, 2299.58 FEET, ALONG THE WEST LINE OF SAID I-95, TO THE POINT OF CURVE OF A CURVE, CONCAVE TO THE SOUTHEAST AND HAVING A RADIUS OF 11,609.16 FEET; THENCE AROUND AND ALONG SAID CURVE AND THE WEST LINE OF SAID I-95, THROUGH A CENTRAL ANGLE OF 03°38'22", AN ARC DISTANCE OF 737.43 FEET (CHORD BEARING AND DISTANCE OF SOUTH 20°15'06" WEST, 737.31 FEET); THENCE DEPARTING THE WEST LINE OF SAID I-95, SOUTH 85°10'15" WEST, 450.41 FEET; THENCE SOUTH 00°40'21" EAST, 311.08 FEET, TO THE NORTH LINE OF OWENS ROAD (A VARIABLE WIDTH RIGHT-OF-WAY); THENCE SOUTH 83°41'22" WEST, 148.23 FEET, ALONG SAID NORTH LINE, TO AN ANGLE POINT; THENCE CONTINUE ALONG SAID NORTH LINE, SOUTH 84°51'59" WEST, 271.57 FEET, TO A TRANSITION POINT IN SAID RIGHT-OF-WAY LINE; THENCE SOUTH 01°51'47" EAST, 17.00 FEET, ALONG SAID TRANSITION, TO THE NORTH LINE OF OWENS ROAD (A 66.0 FOOT RIGHT-OF-WAY), THENCE SOUTH 88°08'13" WEST, 301.53 FEET, ALONG THE NORTH LINE OF SAID OWENS ROAD, TO THE POINT OF BEGINNING,

CONTAINING 5,705,904.75 SQUARE FEET AND/OR 130.9895 ACRES.
