6 AN ORDINANCE REPEALING SECTION 382.309  
7 (DETERMINATION OF ANNUAL RATE OF COMPENSATION  
8 AND MEASURE OF CONTRACT COMPENSATION), PART 3  
9 (SELECTION OF WASTE COLLECTION AND DISPOSAL  
10 SERVICE AREAS AND CONTRACTORS), CHAPTER 382  
11 (WASTE COLLECTION AND DISPOSAL SERVICE BY  
12 CONTRACTORS AND CITY), *ORDINANCE CODE*; PROVIDING  
13 CODIFICATION INSTRUCTIONS; PROVIDING AN  
14 EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Repealing Section 382.309 (Determination of**  
18 **annual rate of compensation and measure of contract compensation),**  
19 **Part 3 (Selection of Waste Collection and Disposal Service Areas and**  
20 **Contractors), Chapter 382 (Waste Collection and Disposal Service by**  
21 **Contractors and City), *Ordinance Code*. Section 382.309**  
22 **(Determination of annual rate of compensation and measure of contract**  
23 **compensation), Part 3 (Selection of Waste Collection and Disposal**  
24 **Service Areas and Contractors), Chapter 382 (Waste Collection and**  
25 **Disposal Service by Contractors and City), *Ordinance Code*, is hereby**  
26 **repealed. A copy of the repealed Section 382.309 is attached hereto**  
27 **as Exhibit 1.**

28 **Section 2. Codification Instructions.** The Codifier and the  
29 Office of General Counsel are authorized to make all chapter and  
30 division "tables of contents" consistent with the changes set forth  
31 herein. Such editorial changes and any other changes necessary to

1 make the *Ordinance Code* consistent with the intent of this legislation  
2 are approved and directed herein, and changes to the *Ordinance Code*  
3 shall be made forthwith and when inconsistencies are discovered.

4       **Section 3.       Effective Date.**   This Ordinance shall become  
5 effective upon signature by the Mayor or upon becoming effective  
6 without the Mayor's signature.
