ΑN ORDINANCE APPROPRIATING \$38,091 FROM A GENERAL FUND OPERATING SPECIAL COUNCIL CONTINGENCY ACCOUNT TO THEGENERAL FUND OPERATING SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT TO PROVIDE CITY GRANT FUNDING TO BEN'S PLACE SERVICES INC. ("BEN'S PLACE") FOR THE LOW-COST TRANSITIONARY DAY PROGRAM "PROGRAM") AS DESCRIBED HEREIN; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH BEN'S PLACE; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND BEN'S PLACE FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY THE GRANTS CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above is an appropriation of \$38,091 from a General Fund Operating Special Council Contingency account to the General Fund Operating Subsidies and Contributions to Private Org account to provide a grant to Ben's Place Services Inc. ("Ben's Place") for the Low-Cost Transitionary Day Program (the "Program") as described herein.

Section 2. The purpose of the appropriation in Purpose. Section 1 is to provide grant funds from the City of Jacksonville to Ben's Place Services Inc. for the Low-Cost Transitionary Day Program as described in Exhibit 2, attached hereto and incorporated herein by this reference. The Program was designed to provide an opportunity for adult Duval County residents with disabilities who have timed out or aged out of high school at the age of 22 to continue to have daily interaction and social contact with friends and others. Participants in the Program are able to gather and socialize while they learn life skills, including proper self-care and hygiene, and to enjoy outdoor activities, making arts and crafts, and attending special events and parties. The Program serves a secondary function by also allowing an opportunity for caregivers to run errands or attend to personal needs while their disabled loved one is enjoying Program activities. The City funds will be used to pay a portion of the salary for a Social Skills Coordinator to help administer the Program and will also help to offset costs for various office, craft and other supplies for the

Program.

Section 3. Waiver of Section 118.107, Ordinance Code. The provisions of Section 118.107 (Nonprofits to receive funding through a competitive evaluated award process), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow for a direct contract with Ben's Place. This waiver is justified because once a disabled individual is no longer able to attend school, it can be difficult to find regular programs and services to aid in continuity of social interaction and life-skills education. Ben's Place has filled this need by providing such programming to serve both disabled adults who are no longer in school and their caregivers for over 20 years.

Section 4. Approval and Authorization to Execute. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City a grant agreement with Ben's Place Services Inc. in an amount not-to-exceed \$38,091, subject to the Term Sheet and Budget more particularly described in Exhibit 2, for a term commencing on October 1, 2024 through September 30, 2025, and all other contracts and documents, including extensions, renewals and amendments to the agreement, and to otherwise take all action necessary to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the General Counsel, or his or her designee, and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 5. Oversight Department. The Grants and Contract Compliance Division of the Finance Department shall oversee the project described herein.

Section 6. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective

without the Mayor's signature.
