5 AN ORDINANCE TO ADDRESS FOOD DESERTS,
6 APPROPRIATING \$150,000.00 FROM THE NORTHWEST OED
7 FUND/CONTINGENCY TO PROVIDE FUNDING TO THE
8 JACKSONVILLE TRANSPORTATION AUTHORITY FOR THE
9 "DOOR-TO-STORE PROGRAM" (THE "PROGRAM"), A
10 COMPONENT OF THE FULL-SERVICE GROCERY STORE
11 IMPROVEMENT PROGRAM ("PROGRAM") ESTABLISHED
12 UNDER ORDINANCE 2019-812-E, AS INITIATED BY B.T.
13 24-010; APPROVING AND AUTHORIZING THE MAYOR, OR
14 HER DESIGNEE, AND THE CORPORATION SECRETARY TO
15 EXECUTE AND DELIVER THAT CERTAIN THIRD AMENDED
16 AND RESTATED FUNDING AGREEMENT BETWEEN THE CITY
17 OF JACKSONVILLE AND THE JACKSONVILLE
18 TRANSPORTATION AUTHORITY ("JTA") TO EXTEND THE
19 TERM OF THE PROGRAM FOR AN ADDITIONAL THREE (3)
20 YEAR TERM; PROVIDING FOR CITY OVERSIGHT AND
21 PROGRAM ADMINISTRATION BY THE OFFICE OF ECONOMIC
22 DEVELOPMENT; PROVIDING AN EFFECTIVE DATE.

24 **BE IT ORDAINED** by the Council of the City of Jacksonville:

25 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
26 within the City's budget, there are hereby appropriated the indicated
27 sum(s) from the account(s) listed in subsection (a) to the account(s)
28 listed in subsection (b):

4 (c) Explanation of Appropriation:

5 The funding above is a transfer of funds from the Northwest
6 OED Fund/Contingency to the Northwest OED Fund/Subsidies
7 and Contributions (the "Trust Fund") to fund a grant to
8 the Jacksonville Transportation Authority (JTA) to enable
9 the continued operation of the Program for an additional
10 three (3) year term.

11 **Section 2. Purpose.** The purpose of the appropriation in
12 Section 1 is to fund the Program in the amount of \$150,000 for an
13 additional three (3) year term. The Program provides complimentary
14 on-demand transportation services to local grocery stores for
15 residents of the Northwest Jacksonville Economic Development Fund
16 Area (the "Area") and incentivizes the operation of new supermarkets
17 and healthy food programs within the Area. Any program funds
18 remaining upon the expiration or termination of the Agreement shall
19 be returned to the City.

20 **Section 3. Approval and authorization for the Third Amended**
21 **and Restated Funding Agreement.** There is hereby approved, and the
22 Mayor, or her designee, and the Corporation Secretary are hereby
23 authorized to execute and deliver, for and on behalf of the City,
24 that certain Third Amended and Restated Funding Agreement (the
25 "Agreement") between the City of Jacksonville and the Jacksonville
26 Transportation Authority attached hereto as **Exhibit 2** and
27 incorporated herein by this reference. The purpose of the Agreement
28 is to extend the term of the Program for an additional three (3)
29 years and provide \$150,000 of funding for said term.

30 **Section 4. Oversight Department.** The Office of Economic
31 Development shall oversee and administer the Program described
