Justification for / Description of Transfer:

As part of the FY26 Finance Committee budget hearings, City Council calculated a 2% extraordinary lapse of controllable costs and placed negative budget amounts at the center level in account 558040 Expenditure Credit-Contingent Lapse. This effectively reduced the total budget for each non-departmental center while leaving the base account strings unchanged. This legislation uses a projected favorable budgetary balance in debt management fund principal to remove City Council 2% extraordinary lapse for General Fund Non-Departmental centers totaling \$2,275,086.00 and moves the same amount out of the City Council 2% extraordinary lapse contingency (one time source) and transfers it to the Multiyear Programs and Initiatives fund 00129 to help fund upcoming Gateway 2024-495 completion grants (one-time use).
