A RESOLUTION HONORING THE LIFETIME OF ACHIEVEMENTS AND MOURNING THE PASSING OF CALVIN BURNEY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Calvin Burney was born February 4, 1953 and grew up in North Carolina. He earned a Bachelor's in Science from the Historically Black University, Fayetteville State, and then his Master's degree in city planning at the Georgia Institute of Technology; and

WHEREAS, Calvin Burney made the city of Jacksonville his adopted home when he came to Northeast Florida in 1978 to work for the Regional Planning Council as a planner for seven Northeast Florida counties. Jacksonville is also where Calvin found his soulmate when he met and married Betty; and

WHEREAS, in 1986 Calvin Burney became a planner for the Florida Department of Transportation. In 1989, Mayor Tommy Hazouri appointed him to the twin roles of Chief of Transportation for the City and Director of the Jacksonville Metropolitan Planning Organization; and

WHEREAS, Calvin Burney was known as a visionary transportation and city planner, able to plan for decades into the future amongst layers of complicated requirements and regulations. He had a hand in many of Jacksonville's largest projects, including the expansion of Mayo Clinic to St. Johns Town Center, the J. Turner Butler corridor, Gate Parkway, the Brooklyn neighborhood, and Dames Point; and

WHEREAS, from 2011 to 2015 Calvin Burney was the Director of the Planning and Development Department for Jacksonville during Mayor Alvin Brown's administration. Upon his retirement, Calvin spent his
