OPERATING - SERE REGISTRATION - OTHER GENERAL
GOVERNMENTAL - EMPLOYEE TRAINING EXPENSES
ACCOUNT, TO ALLOCATE A REIMBURSEMENT OF FUNDS
USED IN SUPPORT OF THE OCTOBER 2025 FLORIDA
CERTIFIED ELECTION PROFESSIONALS (FCEP)
SESSION, HOSTED BY THE DUVAL COUNTY SUPERVISOR
OF ELECTIONS, AS INITIATED BY B.T. 26-031;
PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

The funding above represents an appropriation of \$2,408.74 within the General Fund Operating - Sere Registration -

2 Charges Account, to the General Fund Operating - Sere
3 Registration - Other General Governmental - Employee
4 Training Expenses Account, to reimburse funds initially
5 charged to the Employee Training Account, for expenses
6 related to the Florida Certified Election Professionals
7 (FCEP) Session, hosted by the Duval County Supervisor of
8 Elections in October of 2025.

9 **Section 2. Purpose.** The purpose of the appropriation in
10 Section 1 is to allocate a reimbursement of funds used in support of
11 the Florida Certified Election Professionals (FCEP) Session, hosted
12 by the Duval County Supervisor of Elections (the "SOE") in October
13 2025. The SOE was responsible for providing breakfast, lunch, snacks,
14 beverages and paper products during the training, and reimbursement
15 for those expenses has been received from the Florida Supervisor of
16 Elections.

17 **Section 3. Effective Date.** This Ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
