9 SERVICE GRANTS; PROVIDING FOR CITY OVERSIGHT BY
10 THE OFFICE OF GRANTS AND COMPLIANCE OF THE
11 DEPARTMENT OF FINANCE AND ADMINISTRATION;
12 REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION;
13 PROVIDING AN EFFECTIVE DATE.

15 **WHEREAS**, Ordinance 2021-509-E appropriated \$3,147,080 to
16 Public Service Grants and was moved from a PSG Contingency Account
17 for fiscal year 2021-2022; and

18 **WHEREAS**, Ordinance 2021-157-E also appropriated \$450,469.14
19 from a Special Events-Florida Game Contingency Account to provide
20 additional funding for Public Service Grants for fiscal year 2021-
21 2022; and

22 **WHEREAS**, the \$450,469.14 in additional funding was never
23 transferred from the PSG Contingency Account to a PSG Expense
24 Account; now therefore

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
27 within the City's budget, there are hereby appropriated the
28 indicated sum(s) from the account(s) listed in subsection (a) to
29 the account(s) listed in subsection (b):

(c) **Explanation of Appropriation** - The funding above is being appropriated from the designated Council Contingency account for Public Service Grants.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to transfer funds from the Council Contingency account for Public Service Grants to the Public Service Grants expense account for Subsidies and Contributions to Private Organizations, in order to provide additional funding for the fiscal year 2021-2022 Public Service Grants.

Section 3. Oversight Department. The Office of Grants and Compliance of the Finance and Administration Department shall oversee the project described herein.

Section 4. Requesting Emergency Passage Pursuant to Council Rule 4.901 Emergency. Emergency passage of this legislation upon introduction is requested. The nature of the emergency is to expedite the contracting of services to agencies who require the funding for operations and programming.

Section 5. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
