Section 1. Findings. It is hereby ascertained, determined, found and declared as follows:

- (a) The recitals set forth herein are true and correct.
- (b) The authorizations provided by this Ordinance are for public uses and purposes for which the City may use its powers as a consolidated municipal and county political subdivision of the State of Florida and may expend public funds, and the necessity in the public interest for the provisions herein enacted is hereby declared as a matter of legislative determination.

Approved and Execution Authorized. There is hereby approved, and the Mayor, or her authorized designee, and Corporation Secretary are hereby authorized to execute and deliver, a Supplemental Community Benefits Agreement setting forth the strategic focus and respective additional community investments to be made by the City and JJL over the Stadium Lease term substantially in the form placed On File with the Legislative Services Division (the "Agreement"), with such "technical" changes as herein authorized.

The Agreement may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or her designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor or her designee. No modification to the Agreement may increase the financial obligations or the liability to the City and any such modification shall be technical only and shall be subject to appropriate legal review and approval of the Office of General Counsel and all other appropriate action required by law. "Technical" is herein defined as including, but not limited to, changes in legal descriptions and surveys, descriptions infrastructure improvements and/or any road project, ingress and

egress, easements and rights of way, design standards, access and site 1 plan, which have no financial impact. 2 3 Oversight Department. The Office of Economic Section 3. 4 Development shall oversee the Agreement described herein. 5 Section 4. Effective Date.
