AN ORDINANCE MAKING CERTAIN FINDINGS AND APPROPRIATING \$3,451,837.90 IN CARES ACT FUNDS PREVIOUSLY PLACED IN A CONTINGENCY ACCOUNT AND \$3,752,900.41 OF CARES ACT FUNDS PREVIOUSLY PLACED IN A MISCELLANEOUS GRANTS AND AIDS ACCOUNT TO BE PLACED IN THE SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT TO BE USED FOR BUSINESS RELIEF GRANTS TO THOSE BUSINESSES WHO SUFFERED NEGATIVE IMPACTS DUE TO COVID-19, AS INITIATED BY REVISED B.T. 20-103; AUTHORIZING DISBURSEMENT OF \$7,204,738.31 BUSINESS RELIEF GRANT FUNDS TO BUSINESSES AND IN SUCH AMOUNTS AS SET FORTH ON REVISED EXHIBIT 1 ATTACHED HERETO, \$3,451,837.90 FROM THE \$20,000,000 IN CARES ACT GRANT FUNDING PREVIOUSLY APPROPRIATED BY ORDINANCE 2020-235-E (THE "BUSINESS RELIEF GRANT FUNDS"), AND \$3,752,900.41 FROM THE \$26,500,000 PREVIOUSLY APPROPRIATED BY ORDINANCE 2020-201-E AND ORDINANCE 2020-235-E (THE "COVID-19 SMALL BUSINESS RELIEF AND EMPLOYEE RETENTION GRANT PROGRAM") TO PROVIDE ADDITIONAL FUNDING TO FOR-PROFIT AND NON-PROFIT BUSINESSES WITHIN DUVAL COUNTY NEGATIVELY IMPACTED BY COVID-19 RESPONSE

MEASURES; AUTHORIZING THE CITY TO ENTER INTO GRANT AGREEMENTS WITH RECIPIENTS; INVOKING THE EXCEPTION OF 126.107(G) (EXEMPTIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, DIRECT CONTRACT WITH GRANT RECIPIENTS; AMENDING 2020-328-E AND REPLACING THE GRANT RECIPIENT LIST APPROVED; REQUESTING THAT THE FINANCE AND ADMINISTRATION DEPARTMENT AND OFFICE OF ECONOMIC DEVELOPMENT OVERSEE THE COVID-19 BUSINESS RELIEF GRANT PROGRAM; REQUESTING ONE-CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Novel Coronavirus Disease 2019 ("COVID-19") is a severe, acute respiratory illness that can spread among humans through respiratory transmission and presents with symptoms similar to those of influenza; and

WHEREAS, the World Health Organization previously declared COVID-19 a public health emergency of international concern; and

WHEREAS, on March 9, 2020 the Governor of the State of Florida declared a state of emergency exists in the State of Florida in regard of COVID-19; and

WHEREAS, on March 13, 2020, Mayor Lenny Curry of the City of Jacksonville proclaimed and declared a state of emergency exists in Duval County associated with COVID-19; and

WHEREAS, also on March 13, 2020, President Donald J. Trump declared a national emergency to combat COVID-19; and

WHEREAS, as elsewhere in the country, the citizens and businesses of Duval County are suffering severe economic impacts stemming in part from national, state and local measures closing certain businesses, public schools, public beaches, imposing

emergency work-at-home requirements and limiting public gatherings (the "Emergency Measures") in an effort to slow the infection rate of COVID-19; and

WHEREAS, as a result of COVID-19 and the resulting Emergency Measures, the City also desires to appropriate and authorize disbursement of \$3,451,837.90 of CARES Act funding previously appropriated by Ordinance 2020-235-E and \$3,752,900.41 of CARES Act funding previously appropriated by Ordinance 2020-201-E and Ordinance 2020-235-E to those business entities located in the City of Jacksonville that have suffered economic harm as a result of COVID-19, in such amounts as set forth on Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Recipient List, August 3, 2020 - NCSPHS" attached hereto; and

WHEREAS, disbursement of the Business Relief Grant funds is intended to lessen the severe economic impacts of COVID-19 to businesses located in Duval County, to partially reimburse costs of business interruption and assist in the economic recovery in Duval County from the impacts of COVID-19; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Findings. It is hereby ascertained, determined, found and declared as follows:

- (a) The recitals set forth herein are true and correct.
- (b) By incentivizing job creation and retention of employees the grant program authorized hereby is designed to benefit both individuals and businesses and will promote and further the public and municipal purposes of the City and serve to limit the severe economic impacts of COVID-19.
- (c) The Business Relief Grants are designed to provide rapid economic relief to businesses in the City in order to maintain the viability of such businesses and the employment of individuals thereof, thus maintaining the City's tax base and revenues, and

provide economic assistance to individuals financially harmed from the impacts of COVID-19 and are necessary expenditures incurred due to the public health emergency with respect to COVID-19.

- Enhancement of the City's tax base and revenues, are matters of State and City policy and State and City concern in order that the State and its counties and municipalities, including the City, shall not continue to be endangered by unemployment, underemployment, economic recession, poverty, crime and disease, and consume an excessive proportion of the State and City revenues because of the extra services required for police, fire, accident, health care, elderly care, charity care, hospitalization, public and housing assistance, and other forms of housing public protection, services and facilities.
- The grants authorized hereby will provide economic relief to businesses located in the City of Jacksonville, thus encouraging ongoing compliance with the Emergency Measures and benefitting the health, safety and welfare of the citizens of Duval County.
- The provision of the City's assistance as set forth (f) herein is necessary and appropriate, and the City's assistance is reasonable and not excessive, taking into account the extent of the public benefits expected to be derived from the grants authorized hereby, and taking into account all other forms of assistance available.
- The authorizations provided by this Ordinance are for public uses and purposes for which the City may use its powers as a county, municipality and as a political subdivision of the State of Florida and may expend public funds, and the necessity in the public interest for the provisions herein enacted is hereby declared as a matter of legislative determination.
- This Ordinance is adopted pursuant to the provisions of Chapters 163, 166 and 125, Florida Statutes, as amended, the City's

Charter, and other applicable provisions of law.

Section 2. Appropriation. For the 2019-2020 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

\$3,451,837.90 of the funding above is from CARES Act funds placed in a Contingency account to be placed in the Subsidies and Contributions to Private Organizations account, and \$3,752,900.41 of the funding above is from CARES Act funds place in the COVID-19 Small Business Relief Grant Program/Miscellaneous Grants and Aids account to be placed in the Subsidies and Contributions to Private Organizations account to be used for business relief grants to those businesses who suffered negative impacts due to COVID-19.

Section 3. Purpose. The purpose of the appropriation in Section 2 is to provide funding to be used for business relief grants to those businesses who suffered negative impacts due to COVID-19 as identified in Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Recipient List, August 3, 2020 - NCSPHS" attached hereto and incorporated herein by reference.

Section 4. Business Relief Program grants approved. By this Ordinance, the City is authorized and directed to provide

Business Relief Grants to those Duval County businesses (collectively, the "Grant Recipients") and in such amounts as set forth on **Revised Exhibit 1**, labeled as "Revised Exhibit 1, Rev Recipient List, August 3, 2020 - NCSPHS" attached hereto and incorporated herein by reference.

Section 5. Agreement approved and execution authorized. There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, grant agreements between the City of Jacksonville and the Grant Recipients in substantially the form attached hereto as Exhibit 3. Each Agreement provides for CARES Act grants funds in such amounts as set forth in Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Recipient List, August 3, 2020 - NCSPHS." The Agreements may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor, or his designee; provided however, no modification the Agreement increase the financial to may obligations or liability of the City to an amount in excess of the amount stated in the Agreement or decrease the duties obligations of the Grant Recipients as stated in the Agreement, and any such modification shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other non-substantive changes that do not substantively increase the duties and responsibilities of the City under the provisions of the Agreement, including any amendments deemed necessary to comply with Federal law applicable to the grant funds authorized by the Agreements.

Invoking the exception to Section 126.107(g), Section 6. Ordinance Code. The City is hereby authorized to enter into grant agreements with the grant recipients set forth on Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Recipient List, August 3, 2020 - NCSPHS" for the purposes of providing non-faith based services to the citizens of Duval County. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect. The failure of a grant recipient to enter into the applicable grant agreement shall render such entity ineligible for the grant funds authorized hereby.

Section 7. Amending 2020-328-E and replacing the grant recipient list. Ordinance 2020-328-E approved a first round of Business Relief Grants for organizations in an amount of \$16,548,162.10. After approval by City Council, one of the organizations notified the City that it would not need the funding due to other revenues received, and it was determined that a grant recipient's legal name needs to be corrected from "Riverside Arts Market, LLC" to "Riverside-Avondale Preservation, Inc." As a result, the grants recipient list, Revised Exhibit 1 to Ordinance 2020-328-E, is hereby amended. The Third Revised Exhibit 1 to 2020-328-E is incorporated herein and attached hereto as Revised Exhibit 4, labeled as "Revised Exhibit 4, 3rd Rev Ex 1 to 2020-328-E, August 11, 2020 - Floor."

Section 8. Oversight Department. The Finance and Administration Department and Office of Economic Development shall provide oversight for the Program.

Pursuant to Council Rule 4.901 Emergency. Once cycle emergency passage of this legislation is requested. The nature of the emergency is that the negative health and economic impacts of COVID-19 are ongoing and immediate economic assistance will assist in maintaining the viability of businesses and financial needs of the citizens of Duval County impacted by the COVID-19 pandemic.

Section 10. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
