**ORDINANCE 2025-433**

AN ORDINANCE APPROPRIATING \$40,000 FROM THE SPECIAL COUNCIL CONTINGENCY ACCOUNT TO THE PROD PARKS, RECREATION AND COMMUNITY SERVICES ADMINISTRATION ACTIVITY - MISCELLANEOUS SERVICES & CHARGES ACCOUNT, TO PROVIDE FUNDS FOR LANDSCAPE IMPROVEMENTS AT THE BALIS COMMUNITY CENTER AND SAN MARCO BRANCH OF THE PUBLIC LIBRARY IN COUNCIL DISTRICT 5; PROVIDING FOR OVERSIGHT BY THE PARKS, RECREATION AND COMMUNITY SERVICES DEPARTMENT; PROVIDING AN EFFECTIVE DATE.
