**ORDINANCE 2025-577-E**

AN ORDINANCE APPROPRIATING \$3,643.62 FROM THE  
CCSS COUNCIL PRESIDENT ACCOUNT SEC 106.504 -  
MISCELLANEOUS SERVICES AND CHARGES ACCOUNT TO  
THE FOOD ACCOUNT TO MAKE FUNDS AVAILABLE TO  
PROVIDE FOOD SERVICE TO THE CITY COUNCIL FOR THE  
REMAINDER OF FISCAL YEAR 2024-2025; REQUESTING  
EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING  
AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

7 **Pursuant to Council Rule 4.901 Emergency.** Emergency passage upon  
8 introduction of this legislation is requested. The nature of the  
9 emergency is to allow the funds appropriated by this Ordinance to be  
10 made immediately available for the Council's use.

11           **Section 4.           Effective Date.** The enactment of this Ordinance  
12 shall be deemed to constitute an internal affair of the City Council  
13 and shall become effective upon signature by the Council President  
14 and Council Secretary.
